

2012 LOGAN COUNTY "My Favorite Pie" Contest

August 4, 2012 – Logan County Fair



1. There is no entry fee to participate in contest, only one entry per participant. Participants must 12 years of age or older, amateur bakers only.

2. Each entry will be numbered, the committee will accept the first nine plus 2 alternates. A schedule will be compiled by the start of the Logan County Fair on **Tuesday, July 31, 2012**. Notification of baking times will be posted in the Fair office. Exhibitors must be present and ready to bake in order determined by official schedule. Building doors will be open at 8:00 am on **Saturday, August 4, 2012**. Baking will start no later than 9:00 am.

3. **Bring One – Bake One** Each participant will be responsible for **2 pies**. **Bring one pie** already baked for the drawing/give-away and a **second pie will be prepared and baked** during the contest. The second pie will be the only one judged and sold at the Auction.

4. Each pie must be made from scratch and in a disposable **9" or 10" pie pan**. You may not use a store-bought pie filling and canned fruit or a pre-made crust. Because of time constraints, pie crust may be made and chilled in advance and ready to roll. Each pie must be a **single or double crust**. **Pies must not require refrigeration before serving**. The Health Department says: **NO PIES THAT REQUIRE REFRIGERATION (i.e. dairy or cream pies)**.

5. **Participants are allowed no outside help**. When entering baking area, participant will bring all needed ingredients, equipment and be prepared to bake. Only exhibitors and "My Favorite Pie" Contest Committee are allowed in Pie Contest area once baking has started. Questions should be directed to Pie Contest Director.

6. All recipes must be turned in complete with ingredient list on a 3" x 5" card, with the recipe name and participant name. Each participant will be provided a poster board to write their recipe which will be displayed at the "My Favorite Pie" Contest area.

7. Judging will start **approximately 12:00 noon on Saturday, August 4, 2012**. Judging will be based on quality, flavor, texture, doneness and overall appearance of the finished pie and not on presentation or stage presence of the participant. The "My Favorite Pie" Contest Committee's decisions and the decision of the judge are final. Winners will be announced after the judging is complete.

Prizes: 1st \$40.00 2nd \$20.00 3rd \$15.00 4th \$10.00

8. At the end of the judging and awarding of prizes, pies will be auctioned with proceeds going to the Logan County Fair Foundation. Auction will take place at **the K. of C Open Pavilion after the Chili Cook-Off at approximately 1:30 pm**. (Participant must be present during Auction)

Fair Directors, Pie Contest Director and committee members, and employees of McEntire's Home Appliance & TV are not eligible. The Fair Association, McEntire's Home Appliance & TV, and Pie Contest Committee are not responsible in case of accidents.
