Mr. Siltman spoke to the committee about the recent passage of the increased ambulance tax levy. He believes \$100,000 to \$125,000 should be earmarked for the purchase and/or maintenance of ambulances. LCPA could then borrow funds at a local bank for the purchase of one or two ambulances and use the future levy funds to make the loan payments. The committee generally agreed with this approach, given the current low interest rates and the high cost of keeping the older equipment operational. However, Mr. Rohlfis expressed concern about the actual interest expense, even if the interest rates seem low. Mr. Siltman will collect some figures and bring them back to this committee so direction can be discussed later.

Mr. Siltman also discussed the paramedics' desire for extended cab units so they would have additional room for coats, etc. since the newer vehicles don't have the extra room. The additional cost would only be approximately \$2300. Again, he indicated he would gather figures and bring them for review at a future meeting.

There was a lost child during the conference which was located very quickly with everyone's help. Mr. Fulscher received the award for Emergency Manager of the Year.
