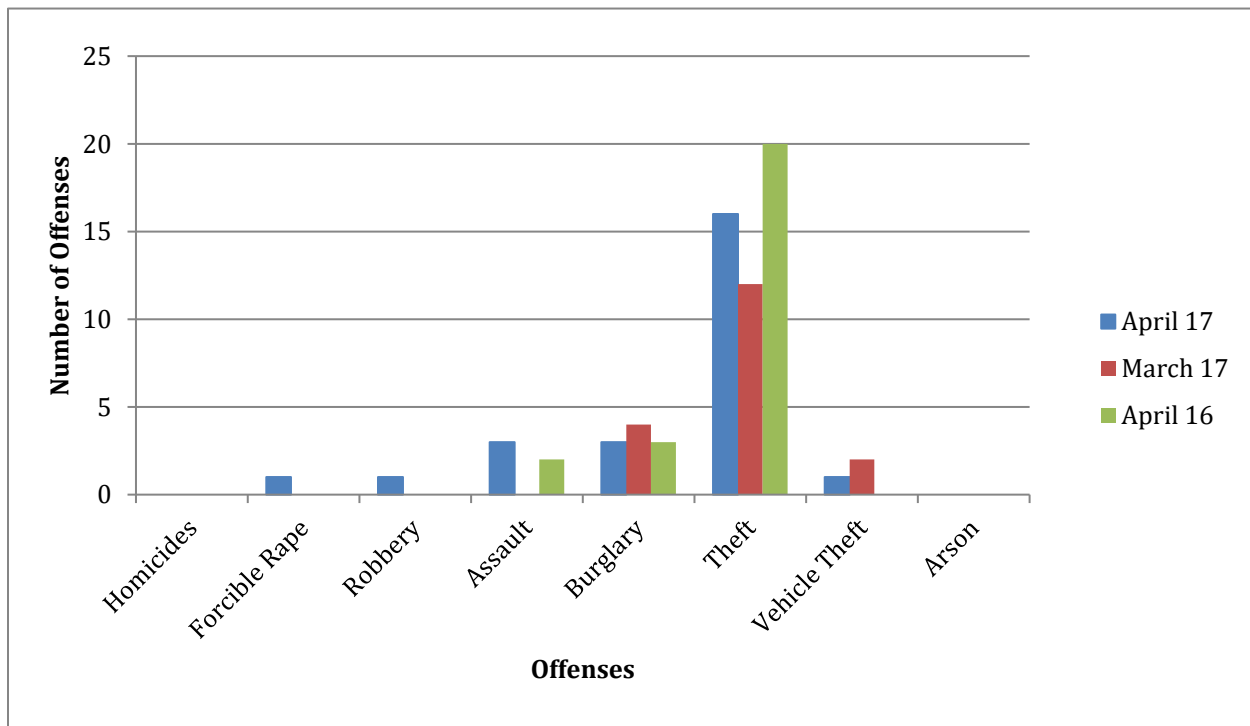
## Uniform Crime Reporting (UCR)

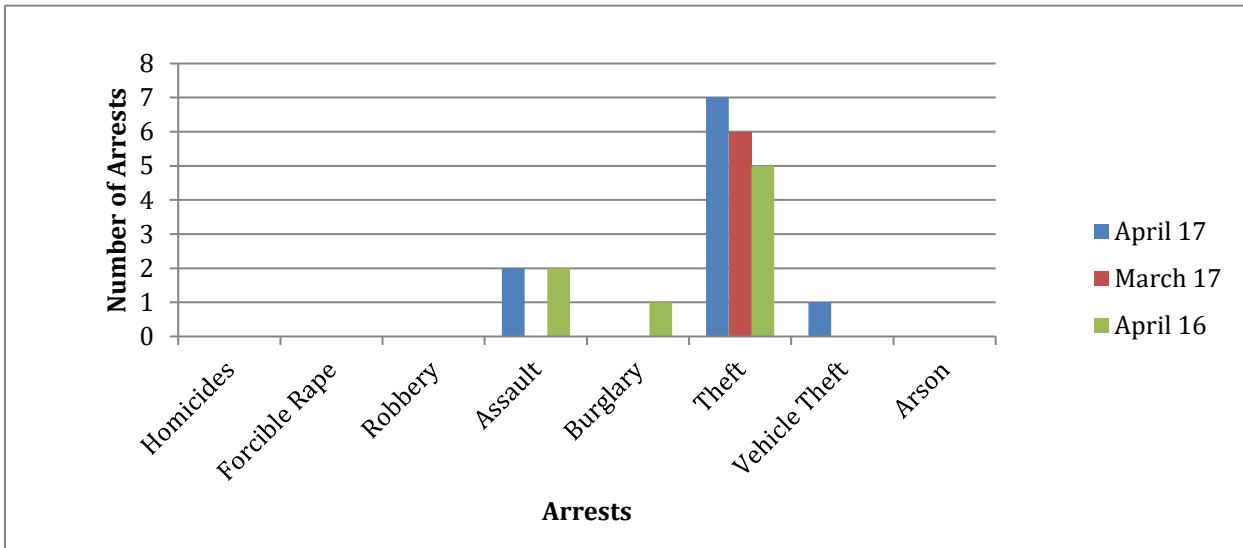

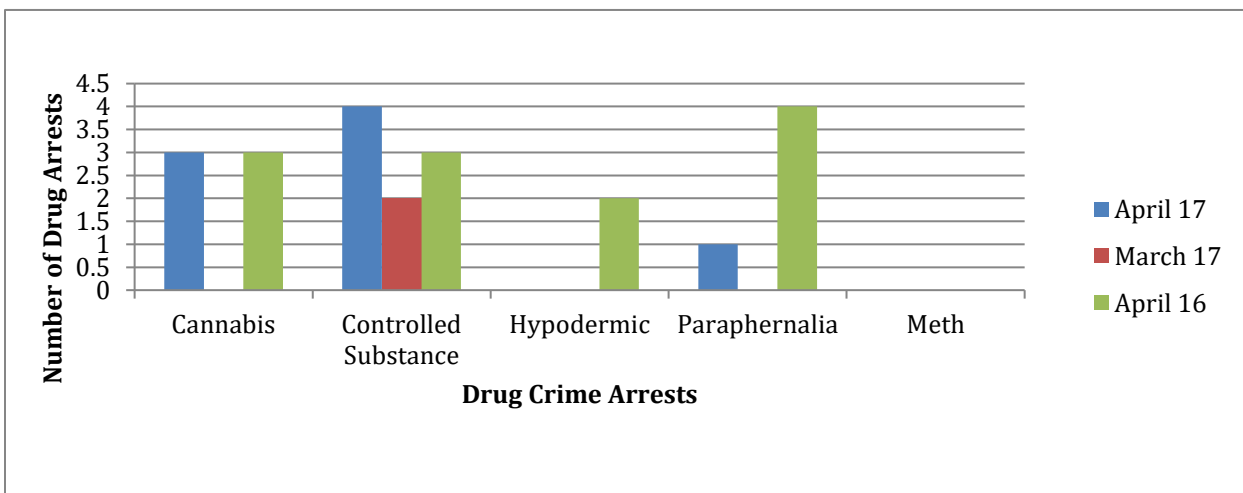

### Patrol

While patrolling the streets in April, the officers wrote 6 City Possession of Cannabis/Possession of Drug Paraphernalia Ordinance Violation in addition to the Traffic Citations and other City Ordinance Citations that were written in April.

### Criminal Investigations

#### Monthly Cases Report Summary for April 2017

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on 23 active criminal investigations in the month of April. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available to for release.

- (6) Investigations were narcotics related. These cases involved the possession and distribution of heroin and cocaine, the production of methamphetamine, controlled substance trafficking, and drug induced aggravated battery.
- (4) Investigations involved property crimes. These cases involved bank robbery, residential burglary, motor vehicle theft, and forgery.
- (6) Investigations involved sexual offenses. These crimes involved both adults and children with offenses including predatory criminal sexual assault, grooming, criminal sexual abuse, and criminal sexual assault and child pornography.
- (3) Investigations involved the death of an individual.
- (2) Investigations were traffic related.
- (2) Investigations involved crimes against persons. These cases included child abuse and aggravated battery.
- Two officers of the Criminal Investigations Division continued to participate in a multi-jurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.



## **DARE/Community Policing**

April 1<sup>st</sup>: Lincoln DARE purchased multiple items to be given as prizes for kids that participated in the youth archery program. Officer Christy Fruge was there to hand out prizes to the kids and their adult guests.

## **LCHS School Resource Officer**

Officer Butterfield responded to 110 incidents at LCHS during April 2017. The most common offenses for April were Class Misconduct, Disciplinary Actions where parents are contacted, Harassment/Bully, Social/Emotional, and Assault/Threat.

The school resource officer attended a digital photography class.
