Crime Mapping

The Lincoln Police Department is pleased to introduce to our community another great way of being involved at keeping our community safe. We have taken advantage of a free service from Motorola to map crimes in our community called CrimeReports available at https://www.crimereports.com/

We want you to be informed and we need your help to control crime. With this service you will have the opportunity to register your address, which is not shared with us. Once you do, you will receive notifications of certain crimes near you and any updates on sex offenders near your registered address.

You will also be able to provide tips on crimes that may have happened near you, like a suspicious vehicle that was driving around the morning of a certain crime. You can also register your video surveillance cameras so we know where there can be possible evidence to help us solve crimes.

We are only listing property crimes; burglaries, thefts, and criminal damage. This is not a representation of all the crimes we investigate on a daily basis as we do not want to provide details on crimes where they are personal, like domestic batteries or sexual offenses.

MONTHLY STATISTICS


Uniform Crime Reporting (UCR)





Patrol

While patrolling the streets in October, the officers wrote 10 City Possession of Cannabis/Possession of Drug Paraphernalia Ordinance Violation in addition to the Traffic Citations and other City Ordinance Citations that were written in October.

Criminal Investigations

Monthly Cases Report Summary for October 2017

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on <u>13</u> active criminal investigations in the month of October. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available to for release.

- (3) Investigations were narcotics related. These cases involved the possession and distribution of cocaine and heroin, drug induced homicide, and drug induced aggravated battery.
- (5) Investigations involved sexual offenses. These crimes involved both adults and children with offenses including criminal sexual assault, sexual exploitation, and grooming.
- (5) Investigations involved crimes against persons. These investigations involved aggravated robbery, armed robbery, home invasion, attempted murder, and aggravated battery of a child.
- (8) Search warrants were executed to further investigations in these cases.

Two officers of the Criminal Investigations Division continued to participate in a multi-jurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.

DARE/Community Policing

October 11th: Lincoln DARE purchased t-shirts for Lincoln Chill softball players. The 8 and under girls were using the shirts for a special tournament they were participating in.

October 12th: Lincoln Police Department participated in the Party in the Park event at Postville Park. Lincoln Police Department cooked hotdogs and Lincoln Dare rented a giant inflatable obstacle course for the kids to play on.

October 12th: Lincoln DARE donated over \$200 for Red Ribbon week for the gifts the school gives out during the week.

October 16th: Lincoln DARE purchased an ad for the Lincoln Railer Boys Basketball team. The basketball team will get a certain amount of money for each AD sold.

October 20th: Sgt. Robert Sherren paid a visit to the Lincoln Junior High School while Officer Christy Fruge visited at Chester East Lincoln. Sgt. Sherren and Off. Fruge spoke with all of the students about Red Ribbon Week which is from October 23rd to October 27th.

October 21st: Lincoln DARE purchased breakfast for a family who had just been involved in a serious crime and were forced out of their home while the investigation was going on. 2 small children were also part of the family. Those kids were given toys, blankets and stuffed animals while they waited at the police department.

October 22nd: Lincoln DARE rented an inflatable game for the West Lincoln Broadwell Fall Festival. Sgt. Sherren joined the kids at the festival. It was a huge success!

October 23rd: Sgt. Sherren went to West Lincoln Broadwell and spoke with the students about Red Ribbon Week. Off. Fruge went to Carroll Catholic and spoke with the pre-school, kindergarten, 1st and 2nd grade classes about making good decisions and being safe on Halloween.

October 24th: Off. Fruge went to Northwest School and spoke with all of the students about Red Ribbon Week. She spent time answering questions for individual kids about drug use and the story behind Red Ribbon Week.

October 25th: Off. Fruge delivered treats to the pre-school thru 2nd grade classes at Carroll Catholic as a Halloween treat. The students were told it was a gift for them being such good listeners when she visited them earlier in the week.

October 27th: Off. Michael Fruge and Off. Christy Fruge joined forces to cook lunch for Carroll Catholic School. They cooked around 100 hotdogs for multiple classes that had won poster contests for Red Ribbon Week. It was cold, but everyone had fun!

October 31st: Lincoln DARE along with the Lincoln Fraternal Order of Police #208 purchased around \$300 in candy for trick or treaters. Cpl. Maurice Johnson, Cpl. Shawn Pettit, Off. Jake Kitner and Off. Keagan Robinson gave out candy in the back parking lot of the Logan County Safety Complex.

Lincoln K9

Officer Sullivan and K9 Ace had 18 deployments for the month of October. Lincoln Police Department requested the K9 Unit 12 times and the Logan County Sheriff's Department requested the LPD K9 Unit 5 times. The K9 indicated 17 out of the 18 deployments. Out of the 17 indications, there were 8 indications where drugs were found and 11 indications drug paraphernalia were found. The drugs indicated were Marijuana, Crack Cocaine and K2 spice.

School Resource

Officer Butterfield responded to 101 incidents at LCHS for the month of October. The most common offenses for the month were Harassment/Bully, Class Misconduct, General incidents were the parents were contacted, Social/Emotional, and Drug Violations.

Officer Butterfield has created a new standard response protocol, for the entire county, for school lock down procedures. Officer Butterfield finished training the Mt. Pulaski schools, Hartsburg/Emden Schools and the New Holland Middletown grade school this month. Officer Butterfield also trained the Logan County Courthouse employees on the SRP Training. Officer Butterfield was able to help with the LCHS Wacky Olympics during Homecoming week.
