A Message from Attorney General Lisa Madigan

This year marks the 10th Anniversary of my annual *Safe Shopping Guide*. Since 2007, when 44 million individual units of children's products were recalled by the U.S. Consumer Product Safety Commission (CPSC), my office has published an annual guide during the busy holiday shopping season to provide you information on dangerous toys and children's products that have been recalled throughout the year. The guide also details the reason for the recall and what action should be taken if you find a recalled product in your home.

This year's recalled products include toys, motorized/electric ride-on toys and scooters, clothing, strollers and other baby gear, as well as furniture and household items. A significant number of toys and clothing items were recalled for choking hazards, including small parts that can break off of toys or snaps and buttons that can detach from clothing. For example, Meijer recalled newborn and toddler swimsuits after receiving 11 reports of snaps detaching from the swimsuits and Hobby Lobby recalled Easter and July 4th light-up toys after a battery cover detached and a 14-month old ingested the coin cell battery. There were also 10 new recalls of furniture for tip-over hazards. Unsecured furniture continues to pose danger to young children, particularly in bedrooms, and families should also always remember to anchor dressers and TVs to walls.

Please take a few minutes to ensure that you do not already have any of these products in your home, in addition to watching out for these products on store shelves, at yard and garage sales, and on secondhand websites such as Craigslist and eBay. As friends and family often save clothing and other baby items to pass down to others years later, you never know when a recalled item may make its way into your home.

In addition, I want to flag safety issues with one of the most popular toys on the market right now – fidget spinners. The toys have not been recalled, but the CPSC has received reports of children choking on pieces of fidget spinners that have come apart and some spinners include a battery which can pose a significant threat if swallowed. The U.S. Public Interest Research Group (PIRG) recently issued a warning about fidget spinners after several purchased online were found to contain high levels of lead. The CPSC has issued the following safety tips about fidget spinners:

- Keep fidget spinners away from children under three years of age.
- Beware of plastic and metal spinners that have small pieces that can be a choking hazard. Choking incidents involving children up to age 14 have been reported.
- Be cautious of "light-up" fidget spinners that may come with button or lithium coin cell batteries. These batteries are an ingestion risk for children and the larger lithium coin cells can lead to severe burns in the esophagus.
- Warn children of all ages not to put fidget spinners or small pieces in their mouths and not to play with the fidget spinners near their faces.

Studio Fun International Recalls Slap Bracelets Sold with Children's Storybooks Due to Laceration Hazard on September 7, 2017. The metal band can wear through the fabric covering of the slap bracelet, posing a laceration hazard. Sold at book and other retail stores nationwide, book fairs and clubs, and online at Amazon.com, Barnesandnoble.com, Walmart.com and other online retailers from September 2016 through August 2017. Hallmark Recalls Plush Baby Stacking Toys Due to Choking Hazard on August 31, 2017. The toys have fabric hats and bows that can detach, posing a choking hazard. Sold at Hallmark Gold Crown stores nationwide and online at Hallmark.com and Amazon.com from June 2016 through July 2017. Consumers should immediately stop using the recalled toys and take them away from children. 


BRIO Recalls Baby Rattles Due to Choking Hazard on August 15, 2017. The wooden rings on the hammer rattles can crack, posing a choking hazard to children. Sold at Home Goods, Kidding Around, Nordstrom and other specialty toy and mass retailer stores nationwide and online at Amazon.com, from March 2015 through June 2017. Consumers should immediately stop using the recalled baby rattles and contact BRIO for instructions on how to receive a full refund or a replacement product of similar value. <https://www.cpsc.gov/Recalls/2017/BRIO-Recalls-Baby-Rattles>



Panelcraft Recalls Children’s Building Sets Due to Choking Hazard August 1, 2017. The building sets corner welds can break, allowing the panels and frames to separate and release magnets during play. When released, exposed magnets can create a choking hazard. Sold at Discount School Supply, Kaplan Early Learning Company, Panelcraft and Tout About Toys from November 2016 through January 2017. Consumers should immediately stop using the recalled building sets and take them away from children. Manhattan Toy Recalls Activity Toys Due to Choking Hazard on July 20, 2017. The colored plastic tubes on the product can become brittle and break into small pieces, posing a choking hazard to infants. Sold at toy stores nationwide and online at www.manhattantoy.com and other websites from May 2015 through September 2016. TOMY Recalls Munching Max Chipmunk Toys Due to Laceration Hazard on July 13, 2017. Parts inside the toy can break creating a sharp point that can penetrate the surface of the toy, posing a laceration hazard. Sold at Babies R Us, Toy R Us and other retail stores nationwide and online at Amazon.com from May 2016 through July 2017. Consumers should immediately take the recalled toys away from children and contact TOMY International to receive a free replacement toy and a TOMY online store coupon. <https://www.cpsc.gov/Recalls/2017/TOMY-Recalls-Munching-Max-Chipmunk-Toys>



Hobby Lobby Recalls Easter and July 4th Light-Up Spinner Toys Due to Choking and Ingestion Hazards on May 23, 2017. The battery cover of the Easter and July 4th-themed light-up spinner toys can detach and expose the small coin cell batteries, posing choking and ingestion hazards to young children. Sold at Hobby Lobby and Mardel stores nationwide from February 2017 to April 2017. Consumers should immediately take the recalled spinners away from children and return them to the nearest Hobby Lobby or Mardel store. Consumers with a receipt will receive a full refund and consumers without a receipt will receive a store credit.

Douglas Recalls Plush Toys Due to Choking Hazard on May 17, 2017. The plastic eyes on the plush toys can detach, posing a choking hazard. Sold at specialty toy and gift stores nationwide from July 2014 to April 2017. Also distributed by UnitedHealthcare Children’s Foundation (UHCCF) to various individuals and organizations.

Little Passports Recalls Science Kits Due to Burn Hazard on May 12, 2017. The battery packs included in the Science Expeditions Northern Lights science kits can overheat, posing a burn hazard to consumers. Sold exclusively online at www.littlepassports.com to Little Passports subscribers in February 2017. Consumers should immediately stop using the battery packs included in the kits and contact Little Passports for a Crystal Growing Kit replacement product or coupon for \$12 off any kit in Little Passports' online store. Horizon Hobby Recalls Remote-Controlled Model Vehicles Due to Fire Hazard on April 25, 2017. The vehicle's electronic speed control (ESC) can fail and short circuit, posing a fire hazard. Sold at Horizon Hobby stores nationwide and online at www.horizonhobby.com from October 2016 through December 2016. Target Recalls Water Absorbing Toys Due to Serious Ingestion Hazard on April 13, 2017. If the small toy is ingested, it can expand inside a child's body and cause intestinal obstructions, resulting in severe discomfort, vomiting, dehydration and could be life threatening. Surgery is required to remove the toy from the body, if ingested. Medical professionals and parents should be aware that there is a possibility that the toys might not show up on an x-ray. Sold at Target stores nationwide from February 2017 through March 2017. Juratoys Recalls Toy Trolleys Due to Impact Injury Hazard on March 29, 2017. The toy trolleys can tip backwards, posing an impact injury hazard to children. Sold at various toy stores nationwide including Giggie and Saks Fifth Avenue, and online at Zulily.com from September 2012 to March 2017. Consumers should immediately stop using the recalled trolleys and keep them out of the reach of young children until they have installed a repair kit. Target Recalls Magnetic Tic Tac Toe Games Due to Choking and Magnet Ingestion Hazards on March 29, 2017. The magnets can come off the tic tac toe game pieces, posing a choking hazard. In addition, when two or more magnets are swallowed, they can link together inside the intestines and clamp onto body tissues, causing intestinal obstructions, perforations, sepsis and death. Internal injury from magnets can pose serious lifelong health effects. Sold exclusively at Target stores nationwide from December 2016 through February 2017. Kids II Recalls Oball Rattles Due to Choking Hazard on March 2, 2017. The clear plastic disc on the outside of the oball rattles can break, releasing small beads, posing a choking hazard to young children. Sold at Target, Walgreens, Walmart and other retailers nationwide and online at Amazon.com, Babyhaven.com, Diapers.com, ToysRUs.com, Walgreens.com and other online retailers from January 2016 through February 2017. Little Tikes Recalls Toddler Swings Due to Fall Hazard on February 23, 2017.

The plastic seat can crack or break, posing a fall hazard. Sold at Walmart, Toys “R” Us and other stores nationwide and online at www.littletikes.com and other websites from November 2009 through May 2014. Consumers should immediately stop using the recalled swings and contact Little Tikes for a refund in the form of a credit towards the purchase of another Little Tikes product. <https://www.cpsc.gov/Recalls/2017/Little-Tikes-Recalls-Toddler-Swings>



Moose Toys Recalls Toy Frogs Due to Chemical and Injury Hazards on February 22, 2017. When the button batteries are removed from the toy frogs, the battery’s cap can become a projectile and the battery’s chemicals can leak, posing chemical and injury hazards. Sold at AAFES, Target, Toys “R” Us and Walmart stores nationwide and online at Amazon.com from August 2016 through February 2017. Feld Entertainment Recalls Toy Wands Due to Injury Hazard on February 9, 2017. The top component of the light-spinner toy wands can detach and expose an 8-inch metal rod, posing an injury hazard to young children. Sold exclusively at Disney On Ice and Disney Live shows from October 2016 through November 2016. Active Kyds Recalls Children’s Toy Shovels and Garden Tool Sets Due to Lead Violations on January 10, 2017. Excessive lead paint levels on the yellow shank and black blade on the shovel, and the black paint on the garden tool set violates the federal lead paint standard. In addition, the black plastic shovel handle and bag clip on the garden tool drawstring bag contain excessive lead content levels, a violation of the federal lead standard. Lead is toxic if ingested by young children and can cause adverse health effect. Sold exclusively at Amazon.com from August 2016 through October 2016. Consumers should immediately take the recalled toy shovels and garden tool sets away from children and contact Active Kyds for a refund.

Toys “R” Us Recalls Infant Wiggle Balls Due to Choking Hazard on October 5, 2017. The wiggle ball’s rubber knobs and plastic back can detach, posing a choking hazard to infants. Sold exclusively at Babies “R” Us and Toys “R” Us stores nationwide from June 2016 through January 2017. Kids Preferred Recalls Wind-Up Musical Toys Due to Choking Hazard on October 19, 2017. The metal post and/or handle of the wind-up mechanism can detach, posing a choking hazard to young children. Sold at Carter’s, Target, Walmart and other stores nationwide and online from January 2016 through August 2017. PlanToys Recalls Baby Gyms Due to Strangulation Hazard on October 25, 2017. Babies can strangle on the side rope crossbars on the baby gyms. Sold at specialty toy and baby product stores nationwide and online at Diapers.com, Target.com and other websites from September 2016 through May 2017. Consumers should immediately stop using the baby gyms and contact PlanToys for a free replacement baby gym.

Rover Recalls Self-Balancing Scooters/Hoverboards Due to Fire Hazard on July 24, 2017. The lithium-ion battery packs in the self-balancing scooters/hoverboards can overheat, posing a risk of smoking, catching fire and/or exploding. Sold at Fallas Stores of Los Angeles, California, and T.J. Maxx and Marshalls stores nationwide from December 2015 through December 2016. 




Dynacraft Recalls Ride-On Toys Due to Fall and Crash Hazards on May 23, 2017. The acceleration pedal on the battery-operated ride-on toys can stick, posing fall and crash hazards. The Surge 12V Camo 4X4 was sold at Walmart nationwide between June 2016 and March 2017. The Surge 12V XL Quad sold at Academy Sports + Outdoors stores nationwide from September 2016 through March 2017. The Tonka 12V Might Dump Truck was sold at Toys R Us stores nationwide and online at ToysRUs.com from July 2016 through November 2016. Consumers should immediately take the recalled ride-on toys away from children and contact Dynacraft to receive a free replacement foot pedal with installation instructions. 

Razor Recalls RipStik Motorized Caster Boards Due to Fall Hazard on April 20, 2017. The rear wheel can stop rotating and lock up while in use, posing a fall hazard. Sold at Target, Toys R Us, Walmart, and other stores nationwide and online at Amazon.com, Razor.com, Target.com, toysrus.com and Walmart.com and other websites from February 2016 through April 2017. 


