MONTHLY STATISTICS


Uniform Crime Reporting (UCR)





Fines

Fines collected, by the Logan County Circuit Clerk, for Lincoln during the month of August were \$5,817.97 bringing the total to \$40,932.49 for the calendar year.

Fines collected for Parking Tickets for the month of August was \$80.00 bringing the total collected this calendar year to \$263.64.

Patrol

While patrolling the streets in July, the officers wrote 7 City Possession of Cannabis/Possession of Drug Paraphernalia Ordinance Violation in addition to the Traffic Citations and other City Ordinance Citations that were written in July.

Criminal Investigations

Monthly Cases Report Summary for August 2017

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on <u>30</u> active criminal investigations in the month of July. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available to for release.

- (13) Investigations were narcotics related. These cases involved the possession and distribution of cocaine and heroin, production of cannabis drug induced homicide, and drug induced aggravated battery.
- (7) Investigations involved sexual offenses. These crimes involved both adults and children with offenses including criminal sexual assault, criminal sexual abuse, and sexual exploitation.
- (3) Investigation involved the death of an individual.
- (4) Investigations involved property crimes.
- (3) Search warrants were executed to further investigations in these cases.
- Two officers of the Criminal Investigations Division continued to participate in a multijurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.

DARE/Community Policing

August 14th: Officer Sullivan and I went to Lincoln College and spoke with the new Resident Advisors. We talked about what to look for it you suspect someone is under the influence, identifying drug paraphernalia and overdose situations.

August 21st: Lincoln DARE purchased dinner tickets from West Lincoln Broadwell. The tickets were given to Lincoln Officers working the day of the dinner. The money will go to the WLB Booster Club.

During the month of August, multiple officers on different days gave out frisbees, bubbles, waffle ball bats and balls, and other toys to kids at the parks in Lincoln.

Lincoln K9

Officer Sullivan and K9 Ace had 23 deployments for the month of August. Lincoln Police Department requested the K9 Unit 20 times and the Logan County Sheriff's Department requested the LPD K9 Unit 2 times. The K9 indicated 12 out of the 23 deployments. Out of the 12 indications, there were 6 indication where drugs were found, 1 indications drug paraphernalia were found and 1 indication where currency was found. The drugs indicated were Cocaine, Marijuana, Heroin and Mushrooms. The amount of currency indicated on was \$2640.00.

School Resource

Officer Butterfield responded to 29 incidents at LCHS during the first two weeks of the 2017-2018 school year. The most common offenses for August were Harassment/Bully, Drug Violations, Class Misconduct and Social/Emotional incidents.

Officer Butterfield has created a new standard response protocol, for the entire county, for school lock down procedures. Officer Butterfield has trained LCHS, Dist. 27, Zion, Chester East and Carroll so far. The first responders training will begin in September.
