There were 25 crashes the Lincoln Police Department responded to for the month.



Uniform Crime Reporting (UCR)






Lincoln Police responded to 1170 incidents for the month of July and 111 case reports were written for the month.



Criminal Investigations

Monthly Cases Report Summary for July 2018

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on <u>16</u> active criminal investigations in the month of June. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available to for release.

- (5) Investigations were narcotics related. These cases involved the manufacture/delivery of a controlled substance, the manufacture of methamphetamine and trafficking and manufacture/delivery of cocaine and cannabis.
- (2) Investigations involved sexual offenses. These crimes involved both adults and children with offenses of criminal sexual assault and criminal sexual abuse.
- (6) Investigations involved crimes against persons. These investigations child abuse and neglect, domestic violence, armed robbery, kidnapping, intimidation, aggravated battery, and drug induced battery in jurisdictions outside of Logan County.
- (3) Investigation involving property related crimes like theft over \$10,000, forgery and money laundering.
- Two officers of the Criminal Investigations Division continued to participate in a multijurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.
- Two officers recently attended training on covert operations and undercover tactics.

DARE/Community Policing

July 11th: Lincoln DARE helped out a family that has fallen on hard times with their child's birthday. I purchased 2 gifts for the child so he could enjoy his day.

July 13th: Officer Kitner joined some kids playing at Scully Park. He gave them some DARE items to make the day at the park even better!

July 21st: Officer Christy Fruge hosted a birthday party of Lane Foster. Lane's mom bid on the special birthday party that was put up as a raffle item at a local school auction event. The party was held at the new police station. The Kids had pizza and were given DARE shirts from the Lincoln DARE program. The party was a success and the kids had a great time!

Lincoln K9

Officer Sullivan and K9 Ace had 8 deployments for the month. Lincoln Police Department requested the K9 Unit 6 times and the Logan County Sheriff's Department requested the LPD K9 Unit 2 times. The K9 indicated 4 out of the 8 deployments. Out of the 4 indications, there were 4 items seized being drugs and/or drug paraphernalia. Total amount of drugs seized was 1.7 grams. The drugs indicated were Morphine and Cocaine along with drug paraphernalia. Officer Sullivan and K9 Ace were also deployed in 2 Human Searches. These searches resulted in 2 arrests along with evidence recovered.

School Resource

Officer Butterfield is assigned to the Criminal Investigation Division while LCHS is on their summer break. Officer Butterfield also assisted with the move to the new Lincoln Police Station.
