# Lincoln Police Department Monthly Report

## **New Laws**

The Illinois Legislature has enacted several new laws effective January 1, 2018. These laws affect how law enforcement does business from investigations to prosecution. In summary the new laws that affect the public:

#### **Sexual Assault Investigations**

Our officers will be trained specifically to investigate and document sex offenses. Our officers will investigate and document every allegation of a sexual assault. If a victim does not want to pursue a complaint, the victim can still report the sex offense anonymously until the victim feels they could pursue the complaint, within the statute of limitations. Even a sexual assault kit, completed at the hospital, can be completed anonymously, as evidence in these cases is very important. #### **Missing Persons Reports**

Officers are now required to provide to those, reporting a missing person, the contact information for the National Center for Missing and Exploited Children, 800.THE.LOST (800.843.5678).

#### **Bail Reform Act**

The Illinois State Legislature split the Illinois Criminal Offenses into 2 categories; Category "A" criminal offenses are the violent crimes and Class X, Class 1 and Class 2 felony offenses. Category "B" criminal offenses are ALL of the other criminal offenses not listed in Category "A." For example, those committing a non-violent property crime, labeled as "Category B," the offender will not be held in jail until they can post a monetary bond. If the arrestee is taken into custody, they will be afforded a bail/bond hearing and if a monetary bond is set, there will be a \$30 per day reduction, for every day they spend in jail. The purpose of this legislation is to level the playing field for those who can afford bail and those who cannot, as those who cannot afford bail, often will sit in jail awaiting trial and spend more time in jail than what the offense sentence may carry. On many misdemeanor offenses, offenders will not be arrested and officers will send reports to the State's Attorney to be prosecuted. This will also require Public Defenders to be present at all bail/bond hearings, which is costing smaller counties such as ours, more money, as this condition/court procedure was not required before.

#### **Fines**

Fines collected, by the Logan County Circuit Clerk, for Lincoln during the month of December were \$2067.64, bringing the total to \$55,956.81 for the calendar year of 2017.

Fines collected for Parking Tickets for the month of December was \$10.00. The total fines collected for calendar year 2017 is \$358.64.

#### **Vehicle Crashes**

There were 35 crashes the Lincoln Police Department responded to for December 2017. Total for the year is 380. The total accident statistics for 2017 are below. Of those 380 crashes the top four types were striking a parked vehicle (111), angle crashes (70), turning (63), and rear end (56).


#### **Uniform Crime Reporting (UCR)**





## **Criminal Investigations**

Monthly Cases Report Summary for December 2017

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on  $\underline{15}$  active criminal investigations in the month of December. The types of investigations are listed. Below is also a look into the amount of cases the Detectives handled for the year of 2017.

- (6) Investigations were narcotics related. These cases involved the manufacture and delivery of cocaine and heroin and drug induced aggravated battery.
- (3) Investigations involved sexual offenses. These crimes involved both adults and children with offenses including criminal sexual assault, criminal sexual abuse and the possession of child pornography.
- (4) Investigations involved crimes against persons. These investigations involved armed robbery and attempted murder.
- (2) Death Investigations.
- (19) Search warrants were executed to further investigations in these cases.
- Two officers of the Criminal Investigations Division continued to participate in a multijurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.



#### Lincoln K9


