Mowing Ordinances

Most of our residents are great at keeping their lawns mowed and not discharging grass into the street. On occasion the Police and Building and Safety Officer receive complaints about residents discharging into the roadway, which along with many other items are illegal as they harm our sewerage system.

When it comes to putting items into the gutters the City Code Section 8-3-8 states the following:

It shall be the duty of every person owning or occupying any lot or parcel of land adjoining any public or private alley in the city to keep the same clean and in an inoffensive condition, and also keep the gutter in front, behind, or beside the premises owned or occupied by him, or under his control, free from filth or other offensive matter, including, but not limited to, landscape waste or leaves, that may prevent the free flow of water therein. No property owner, occupant or any other person shall place, rake, or blow any leaves or landscape waste in any of the public street gutters adjoining their property owned, occupied or at which a person is working for hire or as a volunteer.

We simply ask that you blow your grass into your lawn instead of the gutter and if you happen to or it is necessary to blow your grass into the gutter to please sweep it out as we do have other items our police force should be focusing on.

There were 31 crashes the Lincoln Police Department responded to for April 2018.






Uniform Crime Reporting (UCR)

UCR Report for April 2018








Lincoln Police responded to 1189 incidents for the month of April and 112 case reports were written for the month.



Criminal Investigations

Monthly Cases Report Summary for April 2018

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on $\underline{10}$ active criminal investigations in the month of March. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available to for release.

- (1) Investigation was narcotics related. This case involved the manufacture/delivery of a controlled substance.
- (3) Investigations involved sexual offenses. These crimes involved both adults and children with offenses of criminal sexual assault and criminal sexual abuse.
- (4) Investigations involved crimes against persons. These investigations child abuse and neglect and aggravated domestic battery.
- (2) Investigations were property related crimes. Those involved Theft and Forgery.
- Two officers of the Criminal Investigations Division continued to participate in a multijurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.

DARE/Community Policing

April 4th: Lincoln DARE will be sponsoring a Boy's Baseball Team at the Lincoln Park District.

April 10th: The Lincoln DARE program took over 200 6th grade students to Peoria to watch a Peoria Chiefs Baseball Game.

April 18th: Lincoln DARE made a \$250 donation to the Lincoln Baseball Association. The money will go towards the youth baseball program formally known as Lincoln Heat.

April 18th: Lincoln DARE donated \$64 to the Lincoln Chill fundraising event.

Lincoln K9

Officer Sullivan and K9 Ace had 10 deployments for the month of April. Lincoln Police Department requested the K9 Unit 8 times and the Logan County Sheriff's Department requested the LPD K9 Unit 2 times. The K9 indicated 9 out of the 10 deployments. Out of the 9 indications, there were 4 items seized being drugs and/or drug paraphernalia and alcohol. Total amount of drugs seized was 2 grams. The drugs indicated were Marijuana.

School Resource

Officer Butterfield responded to 54 incidents at LCHS for the month of April. The most common offenses were class misconduct, general disciplinary offenses with parental contacts, social/emotional issues and Harassment/Bully issues. Officer Butterfield went over the new standard response protocol with 14 Churches. Officer Butterfield attended classes on homicide in America, Behavioral Threat Assessment, Digital Threat Assessment and Terrorism Islamic/ISIS Threat Assessment.
