**Resolution for an Advisory Referendum for the  
November 6, 2018 General Election for Firearm Sanctuary County**

Resolution opposing the passage of HB1465, 1467, 1468, 1469, SB1657, any trailer bill, or any bill similar too, or any bill where the 100<sup>th</sup> Illinois General Assembly desires to restrict the Individual right of US Citizens as protected by the Second Amendment of the United States Constitution.

WHEREAS, the Right of the People to Keep and Bear Arms for the defense of Life, Liberty, and Property is regarded as an Inalienable right by the People of Logan county, and;

WHEREAS, the People of Logan County, Illinois derive economic benefit from all safe forms of firearms, recreation, hunting, and shooting conducted within the county using all types of firearms allowable under the United States Constitution, and;

WHEREAS, Logan County Board, being elected to represent the People of Logan County and being duly sworn by Oath of Office to uphold the United Sates Constitution and the Constitution of the State of Illinois, and;

NOW, THEREFORE, IT BE AND IS HEREBY RESOLVED, that the People of Logan County, Illinois do hereby opposed the enactment of any legislation that would infringe upon the Right of the People to keep and bear arms and consider such laws to be unconstitutional and beyond lawful legislative authority.

BE IT FURTHER RESOLVED, that the Logan County Board passed by resolution this day to place the following Advisory Question on the November 6, 2018 General Election ballot as follows:

"Shall Logan County become a sanctuary county for all firearms unconstitutionally prohibited by the government of the State of Illinois, for everyone except undocumented immigrants, in that Logan County will prohibit its employees from enforcing the unconstitutional actions of the state government."

BE IT FURTHER RESOLVED, that the Logan County Board demands that the Illinois General Assembly cease further actions restricting the right of the people to keep and bear arms, and hereby demand that the Governor of Illinois veto all such legislation which restricts the right of the People to keep and bear arms.

BE IT FURTHER RESOLVED, that the Clerk of Logan County is hereby directed to place this advisory referendum on the ballot at the November 6, 2018 General Election and deliver copies of this Resolution to the Office of the Governor of the State of Illinois.
