

**Report Summary** 

March resulted in a rise in thefts, but also a rise in arrests related to theft. Lincoln Police responded to 1127 incidents for the month and 103 case reports were written for the month. Officers responded to 28 vehicle crashes.

Of the 55 arrests for the month, officers arrested several for driving while suspended/revoked, retail theft, domestic battery and warrant arrests. Detectives continued investigations on 21 cases including participating in CIEG task force operations. Patrol officers wrote 99 citations and 140 warnings for the month.

Lincoln Police K9 had 15 deployments that comprised of 9 vehicles. There were 9 indications out of those deployments with 7 items being seized (including drugs, and drug paraphernalia) and 5 arrests were made.

DARE continued to donate to multiple youth organizations and local schools to benefit the children of this community.

Officer Butterfield responded to an array of incidents during the month of March. The most common offenses were Harassment/Bully, class misconduct, general disciplinary offenses with parental contacts, and tobacco/E-Cig violations. Officer Butterfield was instrumental in persuading the City Council of Lincoln to amend the tobacco ordinance for vaping.

On March 18th, 2019, the City of Lincoln amended the tobacco ordinance to include possession and sale of alternative nicotine products to a minor. These will be your "vape, e-cigs, Juuls", etc. The Ordinance is 2019-894 and the statue is Title 3 Section 15 of the Lincoln City Code.

There were 28 crashes the Lincoln Police Department responded to for the month of March.




#### **MONTHLY STATISTICS**


#### **Uniform Crime Reporting (UCR)**

#### **UCR Report for March 2019**











#### **Criminal Investigations**

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on <u>21</u> active criminal investigations in the month of March. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available to for release.

- (5) Investigations were narcotics related. These cases involved the manufacture/delivery of controlled substances such as heroin and the manufacture/delivery of methamphetamine.
- (9) Investigations involved sexual offenses. These crimes involved both adult and child victims with offenses of predatory criminal sexual assault, criminal sexual assault, possession of child pornography, criminal sexual abuse and prostitution.
- (5) Investigations involved crimes against persons. These investigations involved drug induced aggravated battery, domestic battery, and aggravated battery with a weapon.
- (2) Investigations were property related. These cases were burglary and retail theft.
- Two officers of the Criminal Investigations Division continued to participate in a multijurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.
- (3) Search warrants were executed in furtherance of these investigations.

## **DARE/Community Policing**

March 6<sup>th</sup>: Lincoln DARE purchased the WLB 7<sup>th</sup> grade Volleyball team state patches for their shirts.

March 11<sup>th</sup>: DARE donated \$250 to Carroll Catholic Boys Basketball team. The donation will help purchase the banner for the 2<sup>nd</sup> place finish at the State Tournament.

March 11<sup>th</sup>: DARE donated \$250 to the Lincoln Park District to purchase prizes for this year's Easter Egg Hunt.

March 16<sup>th</sup>: Lincoln DARE donated \$100 to a local group that plans to participate in the St. Jude's run.

March 26<sup>th</sup>: Lincoln DARE purchased over \$200 in prizes for the youth archery shoot put on by the YMCA and Dave Duvall.

#### Lincoln K9

Officer Sullivan and K9 Ace continue to be an extraordinary benefit for the entire Lincoln Community. The K9 unit has had 15 deployments for March. On those deployments, there were 15 search areas with 9 being vehicles. There were 9 indications out of the deployments with 7 items being seized, all were drug or drug paraphernalia related. These searches resulted in 5 arrests being made.

#### **School Resource**

Officer Butterfield responded to an array of incidents during the month of March. The most common offenses were Harassment/Bully, class misconduct, general disciplinary offenses with parental contacts, and tobacco/E-Cig violations. Officer Butterfield worked with Lincoln College on their lock down drills procedures. He worked with the LCHS students and staff in training for lock down drills and storm drills. Officer Butterfield was diligent in creating and presenting an Ordinance for E-Cigarettes to the City Council. The City of Lincoln amended the tobacco ordinance on March 18th, 2019 to include possession and sale of alternative nicotine products to a minor. These will be your "vape, e-cigs, Juuls", etc. The Ordinance is 2019-894 and the statue is Title 3 Section 15 of the Lincoln City Code.
