## Report Summary

Lincoln Police responded to 894 incidents for the month and 80 case reports were written for the month. Officers responded to 29 vehicle crashes. Patrol officers wrote 65 citations and 36 warnings for the month, along with 9 City Ordinance Citations.

Of the 54 arrests for the month, officers arrested several for driving while suspended/revoked, illegal consumption, criminal trespass, domestic battery, and warrant arrests. Detectives continued investigations on 23 cases including participating in CIEG task force operations.

Lincoln Police K9 had 6 deployments in the month of July. There were 7 indications and 8 items seized. Out of those deployments, all items seized were drugs and/or drug paraphernalia.

DARE is constantly talking with the community, children and parents alike, trying to inform individuals the way to make choices that will benefit their lives. DARE would like to thank the community for all of its support for this program.

There were 29 crashes the Lincoln Police Department responded to for the month of July.

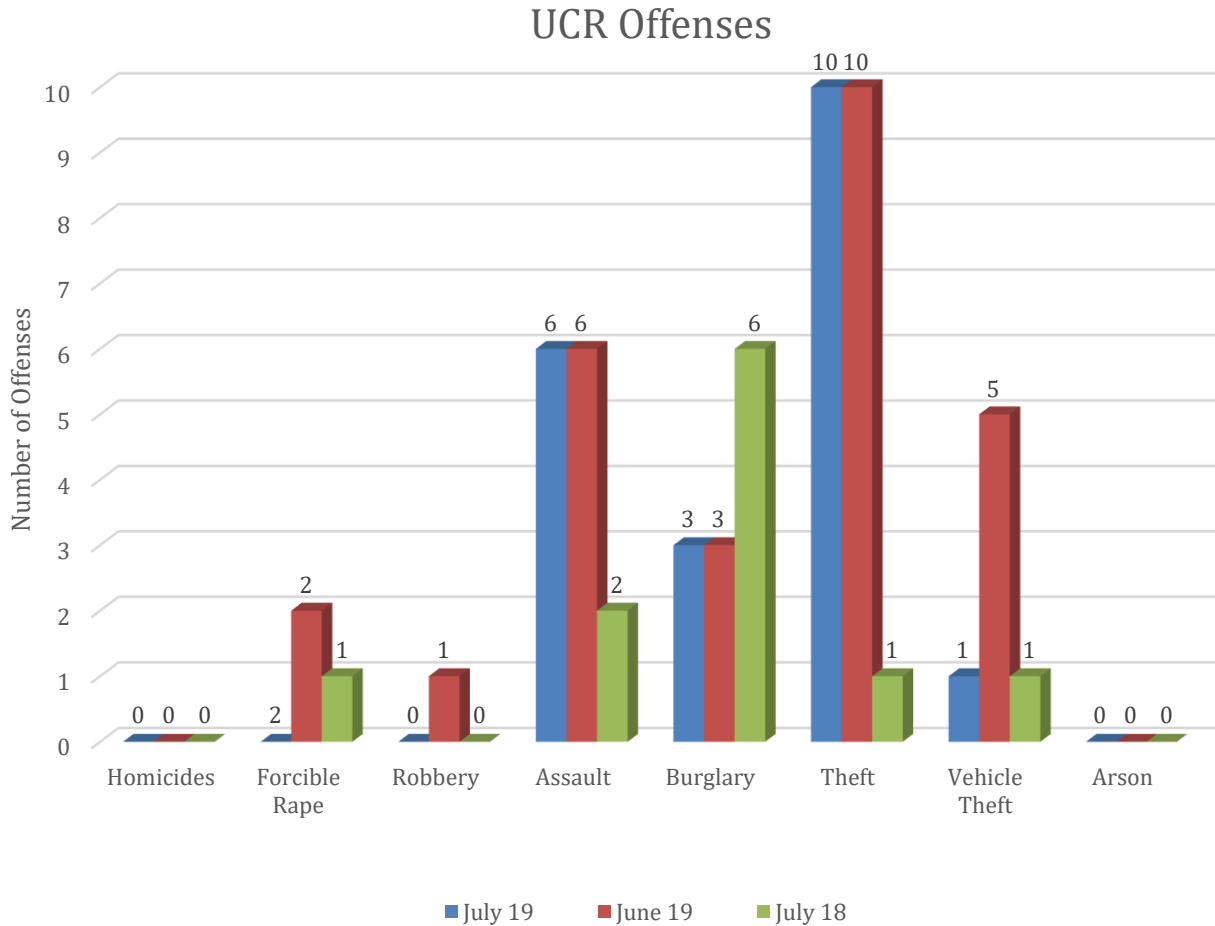

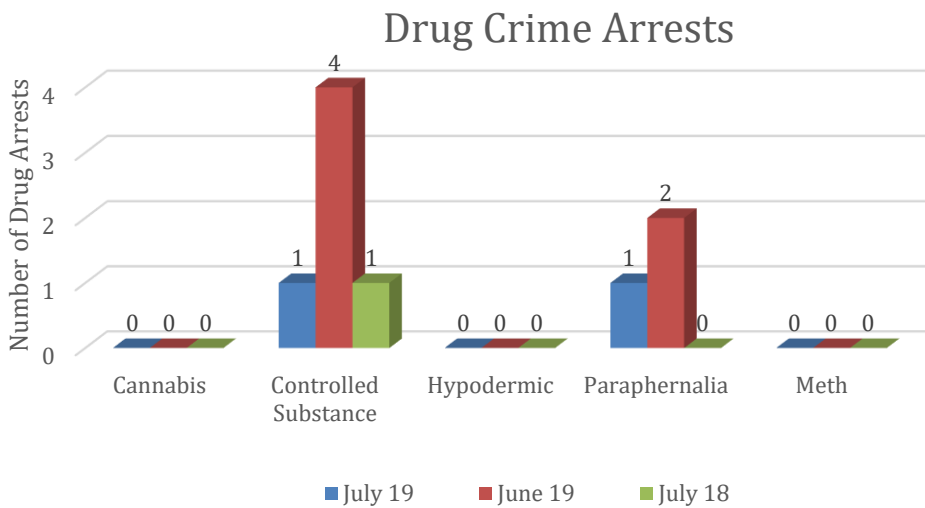
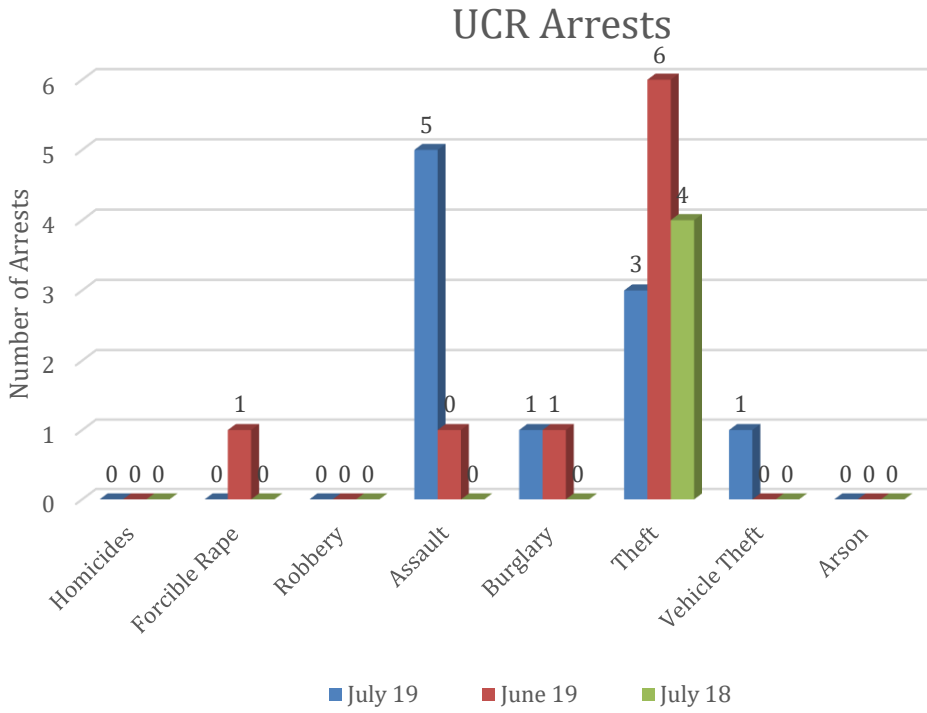
# MONTHLY STATISTICS

### UCR Report for July 2019





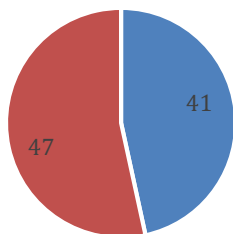

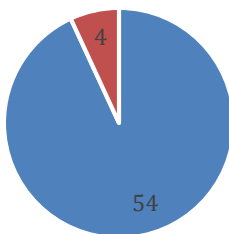

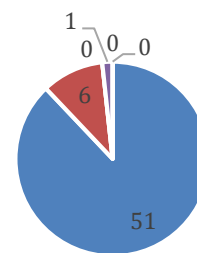

## DIVISION REPORTS

---

### Criminal Investigations

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on 23 active criminal investigations in the month of July. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available to for release.

- (7) Investigations were narcotics related. These cases involved the manufacture/delivery of cocaine, drug induced aggravated battery, drug induced homicide, and the manufacture/delivery of methamphetamines.
- (4) Investigations involved sexual offenses. These crimes involved both adult and child victims with offenses of criminal sexual assault, aggravated criminal sexual assault and aggravated criminal sexual abuse.
- (4) Investigations involved crimes against persons. These investigations involved aggravated battery, domestic battery, and aggravated battery with a weapon.
- (6) Investigations were property related. These cases involved theft, forgery, motor vehicle theft, and fleeing and eluding.
- (1) Suspicious Death Investigation
- (1) Probation Violation Investigation
- Two officers of the Criminal Investigations Division continued to participate in a multi-jurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.
- (2) Search warrants were executed in furtherance of these investigations.
- Continuing education was completed in the areas of Hazardous Materials, Blood borne Pathogens, and Ethics.

### DARE/Community Policing

During the month of July, Officer Christy Fruge had the opportunity to spend some time at the Farmers Market, put on by the Abraham Lincoln Memorial Hospital, on July 20<sup>th</sup>. She spoke to parents about the signs of drug paraphernalia and teens. She also talked with kids about making good decisions. Dare joined forces with the Fraternal Order of Police to donate money to a local family whose son is battling a form of brain cancer.

## Lincoln K9

Officer Sullivan and K9 Ace had 6 deployments for July. The Lincoln Police Department is always benefiting from our K-9 unit. Of the deployments this month, there were 13 search areas with 7 indications, 8 items seized and 2 arrests. All items seized were drug or drug paraphernalia related. The drugs seized were all cannabis.

Officer Butterfield is offering his assistance to the detective's office over the LCHS summer break. He is beneficial in obtain further information for cases being handled by the Lincoln Police Department.
