IN RE: Hydraulic Breaker Replacement

#### Background

The City of Lincoln owns a Bobcat skid steer. One of the attachments we use on this equipment is a hydraulic breaker (commonly known as a jack-hammer). While using these pieces of equipment on the sinkhole on College St. my team noticed both the Bobcat and hydraulic hammer needed some service. Both items were sent to Bobcat of Springfield for repair.

#### Analysis/Discussion

The hydraulic breaker requires an estimated \$4,500 in repairs. This equipment is approximately 20 years old. Bobcat quoted a new and improved hydraulic breaker at a cost of \$9616.80. Because the repair was nearly 50% of the replacement cost I believe it prudent to consider replacing rather than repairing the item. I asked the City Administrator and Mayor for their opinions on repairing vs. replacing the item. We all agreed it was prudent to consider replacing the item rather than repairing an aging piece of equipment. Therefore, I am presenting the option to the council to repair or replace the hydraulic breaker. Rental of a similar breaker is approximately \$750/week, is subject to availability and business hours and must be transported to/from Lincoln making it a less desirable option.

My team gathered 4 quotes for replacement breakers from area equipment dealers:

Bobcat replacement (Bobcat): \$9,616.80 Indeco breaker (Luby Equipment): \$9,850.00 NPK breaker (Martin Equipment): \$11,728.43 Montabert breaker (Roland Machinery): \$8,200

#### Fiscal Impact

The replacement will cost the city \$3,700 more than the repair but will invest the money in a new and improved asset rather than making a repair on a 20 year old item that will mix new and old components.
