

Report Summary

Lincoln Police responded to 979 incidents for the month and 103 case reports were written for the month. Officers responded to 28 vehicle crashes. Patrol officers wrote 82 citations and 57 warnings for the month, along with 7 City Ordinance Citations.

Of the 52 arrests for the month, officers arrested several for Driving Under the Influence, domestic battery, driving while suspended/revoked, retail theft, and warrant arrests. Detectives continued investigations on 22 cases including participating in CIEG task force operations.

Lincoln Police K9 had 9 deployments in the month of October. Out of those deployments, all items seized were drug or drug paraphernalia related. The drugs seized were Cannabis, Heroin and Cocaine.

DARE is constantly trying to help the children of this community with choices inside and outside of the classroom. DARE was awarded a Grant from International Paper to benefit children, in District 27, with clothing and shoes. DARE purchased candy for the Halloween trick-or-treaters, to show kids the fun activities available to them.

The School Resource Officers are having a busy and eventful school year so far. The School Resource Officers are eagerly learning the dynamics of the school environment this year. They are continually working on forming relationships with the students, that will help keep the students and school a safe place.

There were 28 crashes the Lincoln Police Department responded to for the month of October.




Uniform Crime Reporting (UCR)



■ October 19 ■ September 19 ■ October 18









Criminal Investigations

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on <u>22</u> active criminal investigations in the month of October. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available to for release.

- (8) Investigations were narcotics related.
- (8) Investigations involved sexual offenses. These crimes involved both adult and child victims with offenses of criminal sexual assault, aggravated criminal sexual assault, aggravated criminal sexual abuse, and child pornography.
- (3) Investigations involved crimes against persons. These investigations robbery, drug induced battery, and domestic violence.
- (2) Investigations were property related. These cases involved forgery and residential burglary.
- (1) Investigations involved miscellaneous offenses
- Two officers of the Criminal Investigations Division continued to participate in a multijurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.
- (5) Search warrants were executed in furtherance of these investigations.
- Continuing education was completed in the areas of the changing cannabis laws.

DARE/Community Policing

DARE was awarded a Grant, from International Paper, to help kids with clothing needs. She will be distributing the fund, in the form of sweatshirts, jackets, pants, shoes and etcetera, to District 27 school children throughout the school year. DARE is designed to help children make good decisions in life. It is imperative that they have someone or something that will help them remember about those good decisions. Officer Christy Fruge awarded a student with lunch for making multiple good decisions on a continuous basis. DARE hosted a party at Northwest to celebrate the star students for the month. These are the kids that keep their grades up and stay out of trouble. DARE also purchased candy for the Halloween Trick-or-Treaters.

Lincoln K9

Officer Sullivan and K9 Ace had 9 deployments for October. The Lincoln Police Department benefits from our K-9 unit on a regular basis. Along with helping Logan County and Illinois State Police, the US Marshals have asked for our K9 Unit's assistance and benefited from its performance. The deployments this month resulted with outstanding indications, items seized and arrests. All items seized were drug or drug paraphernalia related. The drugs seized were Cannabis, Heroin and Cocaine.

School Resource for LCHS

October has proven to be a busy month for Officer Butterfield. He has been working with multiple schools and the colleges on their safety procedures. He attended a Safe School Summit and learned valuable information to help the schools in our community. The incidents he responded to this month include harassment/bullying issues, drug violations, assault/threat issues, E-cig/vape violations and class misconduct/general incidents that required parental contact. Officer Butterfield help implement a K-9 search, of LCHS, during the month of October.
