

September 2019

Report Summary

Lincoln Police responded to 1096 incidents for the month and 109 case reports were written for the month. Officers responded to 27 vehicle crashes. Patrol officers wrote 75 citations and 63 warnings for the month, along with 10 City Ordinance Citations.

Of the 57 arrests for the month, officers arrested several for domestic battery, retail theft, warrant arrests, driving while suspended/revoked, and Driving Under the Influence. Detectives continued investigations on 20 cases including participating in CIEG task force operations.

Lincoln Police K9 had 9 deployments in the month of September. There were 4 indications, 3 items seized, and 3 arrests. Out of those deployments, all items seized were drug or drug paraphernalia related. The drugs seized were Methamphetamines.

DARE is constantly trying to help the children of this community with choices inside and outside of the classroom. There are some children that need a little extra help with basic things some of us take for granted. DARE is always trying to donate to schools for sports or fundraisers that will give children an option to keep them busy and entertained. Outlets help them to continue to make good choices in their lives.

The School Resource Officers started this school year off running. The School Resource Officers are responsible for safety and crime prevention in the schools. They have been busy getting the schools up to date on their drills to keep the students and staff safe in case of different kinds of emergencies.

There were 27 crashes the Lincoln Police Department responded to for the month of September.




MONTHLY STATISTICS


Uniform Crime Reporting (UCR)

UCR Report for September 2019











DIVISION REPORTS

Criminal Investigations

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on <u>20</u> active criminal investigations in the month of September. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available to for release.

- (7) Investigations were narcotics related. These cases involved the manufacture/delivery of cocaine, manufacture/delivery of heroin, and the manufacture/delivery of methamphetamine.
- (4) Investigations involved sexual offenses. These crimes involved both adult and child victims with offenses of criminal sexual assault, aggravated criminal sexual assault, aggravated criminal sexual abuse.
- (3) Investigations involved crimes against persons. These investigations involved child abuse, unlawful use of a weapon, and domestic violence.
- (3) Investigations were property related. These cases involved forgery and residential burglary.
- (1) Suspicious Death Investigation
- (2) Investigations involved miscellaneous offenses
- Two officers of the Criminal Investigations Division continued to participate in a multijurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.
- (4) Search warrants were executed in furtherance of these investigations.
- Continuing education was completed in the areas of use of force.

DARE/Community Policing

During the month of September, DARE donated to Central Illinois Softball and Lincoln Chill. Due to the fundraising throughout the year, DARE was able to help a student have a wonderful birthday. DARE is designed to help children make good decisions in life. When a child is having a rough patch in their lives, it is imperative that they have someone or something that will help them remember about those good decisions.

Lincoln K9

Officer Sullivan and K9 Ace had 9 deployments for September. The Lincoln Police Department, along with Logan County, is always benefiting from our K-9 unit. Of the deployments this month, there were 6 search areas with 4 indications, 3 items seized and 3 arrests. All items seized were drug or drug paraphernalia related. The drugs seized were Methamphetamines.

School Resource for LCHS

Officer Butterfield has been on a run the whole month of September. He has been working with LCHS on lock down drills, fire drills, off site shelter drills and lock out/active shooter drills. He has been working with LCHS and all the staff members on the new radios for the high school. He has responded to incidents about harassment/bullying issues, class misconduct and incidents that required parental contact, medical issues, assault/threat issues and class misconduct issues.

School Resource for District #27

Officer Christy Fruge is working hard at making the transition phase for both the school and the SRO position at District 27. She is working on the upcoming Red Ribbon Week in October. She has been working with Officer Butterfield in the lockdown drills for all the District 27 schools. During the month of September, she has responded to incidents about general counseling, truancy, harassment/bullying and issues where parental contact was needed.
