

Report Summary

Lincoln Police responded to 1110 incidents for the month and 130 case reports were written for the month. Officers responded to 22 vehicle crashes. Patrol officers wrote 64 citations and 58 warnings for the month, along with 15 City Ordinance Citations.

Of the 56 arrests for the month, officers arrested several for driving while suspended/revoked, warrant arrests, Driving Under the Influence, Methamphetamine Possession, Retail Theft and Violation of Order of Protection. Detectives continued investigations on 16 cases including participating in CIEG task force operations.

Lincoln Police K9 had 15 deployments in the month of August. There were 9 indications, 15 items seized, and 15 arrests. Out of those deployments, all items seized were drugs and/or drug paraphernalia.

DARE is constantly trying to help the children of this community with choices outside of the classroom. There are some children that need a distraction after school. DARE is always trying to donate to schools for sports or fundraisers that will give children an option to keep them busy and entertained. Outlets help them to continue to make good choices in their lives.

The School Resource Officers are gearing up for another school year. District #27 now has a School Resource Officer. The School Resource Officers are responsible for safety and crime prevention in the schools.

Lincoln Police Department hosted a National Night Out on August 6th at Ray White Park. This **night** focuses on the community and raising awareness in the United States. Promoting police-community partnerships and neighborhood camaraderie to make our neighborhoods safer.

There were 22 crashes the Lincoln Police Department responded to for the month of August.




MONTHLY STATISTICS


Uniform Crime Reporting (UCR)

UCR Report for August 2019











DIVISION REPORTS

Criminal Investigations

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on <u>16</u> active criminal investigations in the month of August. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available to for release.

- (3) Investigations were narcotics related. These cases involved the manufacture/delivery of cocaine, drug induced homicide, and the manufacture/delivery of methamphetamine.
- (5) Investigations involved sexual offenses. These crimes involved both adult and child victims with offenses of criminal sexual assault, aggravated criminal sexual assault, aggravated criminal sexual abuse and child pornography.
- (4) Investigations involved crimes against persons. These investigations involved armed robbery, domestic battery, and child abuse.
- (3) Investigations were property related. These cases involved forgery and residential burglary.
- (1) Suspicious Death Investigation
- Two officers of the Criminal Investigations Division continued to participate in a multijurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.
- (3) Search warrants were executed in furtherance of these investigations.
- Continuing education was completed in the areas of Crime Scene Investigation Reconstruction.

DARE/Community Policing

During the month of August, DARE donated to the LCHS Basketball Boosters and the sports clubs of LJHS and WLB. Officer Christy Fruge, Officer Chad Eimer and Corporal Shawn Pettit took the opportunity to grill out hotdogs for a Lincoln Junior High and West-Lincoln Broadwell Baseball game, a little cross town rival event.

Lincoln K9

Officer Sullivan and K9 Ace had 15 deployments for August. The Lincoln Police Department is always benefiting from our K-9 unit. Of the deployments this month, there were 12 search areas with 9 indications, 15 items seized and 5 arrests. All items seized were drug or drug paraphernalia related. The drugs seized were cannabis, Methamphetamines, Trazedone and Alprazolam.

School Resource for LCHS

Officer Butterfield has started off the school year on a run. He has been working with LCHS, CEL and WLB on the Standard Response Protocol. He has responded to incidents about medical conditions, harassment/bullying issues, class misconduct and incidents that required parental contact.

School Resource for District #27

Officer Christy Fruge is the Resource Officer for District #27. She served ice cream at the Ice cream social/Open house at LJHS on August 14th. She was able to meet with many of the kids and their parents to introduce her new role in District #27. She has been working on creating an office space to help kids when they have questions, or when she has question s for them. She is working on planning Red Ribbon Week, which is an alcohol, tobacco, and other drug and violence prevention awareness campaign observed annually in October in the United States. The first day of school was August 16th and Officer Fruge has been busy. She has responded to incidents about fighting, general counseling, and medical issues. Officer Fruge is looking forward to the adventure that this school year brings.
