#### FROM OUR PASTOR...

Dear Friends,

Stay the course! I know, I know. This is going on far longer than we had ever imagined, much less hoped! So, we all need to stay the course to get through this very difficult time in history. Most plagues and diseases have lasted far longer than this one throughout history. Of course, at first, this disease was compared to influenza but of course, this horrible little bug has killed and severely sickened far more than the regular flu ever has already in its time. Because of our increase in cases, it's time to be more diligent.

Tools to help us stay the course are to make peace with staying home as much as possible. Some of us cannot do that, but many of us can. Try NOT to go out in public, even when establishments are open. Order food and take it home or have it delivered. Eat at the outside dining places when you need to. Try hard not to attend gatherings, but if you must, wear your mask, stay 6' away from others and shorten the length of your stay.

Emotions are running very high these days. We need to acknowledge these are times of great stress for other people around us. We are all grieving what we used to have. Grief takes the form of anger, denial, sadness, confusion, bargaining, and acceptance. Some of us have all those feelings in one day! People are angry that we still have to be following protocol. When my husband and I were in Kansas, we went to a county that had only 5 cases, yet people were diligent in wearing masks. One outdoor dining

experience we had, the waiter wearing a mask and gloves lamented: "I don't know why we have to be so careful since we only have 5 cases." I retorted, "Maybe it's because you're all so diligent that you only have had five cases!" Some are still denying that the disease is "that bad" or that we are at much risk. Yet, we have seen what can happen if someone is asymptomatic (without symptoms) but is positive for the disease! We have some who are sad that they cannot visit their loved ones, (me!) and that life is not back to normal yet. We have some who have accepted the way things are and are content in this time of protecting ourselves and others against this monster.

Find solace for your feelings by talking to others on the phone or at a safe distance, praying, staying healthy, being sure to use all protocol and remembering, they are just feelings. Stay the course and when we all are vaccinated, what joy will fill our hearts! Jesus's commandment is to love one another. Let us love one another by protecting one another and we will survive and thrive! I get it. This is so very hard. At the same time, I believe in you! I know you want to protect each other and love each other. God bless us, Church, even when we are scattered!

President Goetsch called the meeting to order at 7:00p.m. on Monday, July 20, 2020, and Pastor Laurie Hill gave the invocation.

#### **CONSENT AGENDA APPROVAL**

It was moved and seconded to accept the agenda as presented. All voting aye, the motion passed.

It was moved and seconded to accept the Consent Agenda as presented. All voting aye, the motion passed.

#### **PASTOR'S REPORT**

Pastor Laurie and Bill Gosda, both located in separate locations, attended the Illinois Conference Meeting via Zoom. They voted on Nominees for Officers and Committee assignments. They voted to change the bylaws, so the meeting date isn't limited to May or June. And they voted in the new Conference Minister, Rev. Molly Carlson. She begins August 1, 2020.

She met with RTech about how to continue the Live Streaming even when we do have in person worship. In order to do this will require another device to help with more distinct sound. Will be discussed later on.

She is co-leading the book study on "White Fragility" with Presbyterian Pastor Quine.

She helped set up Red Cross Blood Drive on June 23<sup>rd</sup>. She attended several Zoom meetings, and the Veteran's Celebration Committee meeting in person. Officiated for a graveside service in Decatur and had one week of vacation in July.

#### **OLD BUSINESS**

Phone System: Comcast was contacted and was to do a walk through the building and get the installation done the week of the 20<sup>th</sup>.

#### **NEW BUSINESS**

- Custodial Position: Warren Goetsch (Council President), Gary Atteberry (Building and Grounds Chair), Bill Gosda, (Interim Custodian), and Pastor Laurie interviewed one candidate. The other candidate did not show up to scheduled interview. Cathy Sanders, daughter-in-law of Bob and Sandy Sanders, was interviewed by the hiring panel. They recommended to the council of St. John UCC to hire Cathy as the custodian. It was moved seconded to accept the recommendation of the hiring panel to hire Cathy Sanders as the custodian at St. John UCC. All voting aye, the motion passed. If Cathy accepts the position she can start immediately, Tuesday, July 21st.
- Church Opening: At the June council meeting the council passed a motion to begin in person services beginning August 2<sup>nd</sup>. However, since there has been a significant increase in Covid -19 positive cases in Logan County in the last several weeks it was discussed to push that opening date to a later time. It was moved and seconded to open the church beginning September 6, 2020. After some discussion, the motion was amended to open the church starting Sunday, August 23, 2020 citing that it's a compromise if the cases start decreasing over the next several weeks, we won't need to wait until September. The motion to the amendment was seconded. All voting aye, the motion passed. The motion to opening the church for in person services with the

- amended date of August 23, 2020 was seconded. All voting aye the motion passed.
- Open House Request: The family of Ilona Pech, who passed away April 6, 2020, has requested they have an Open House in the Fellowship Hall. The council decided as long as the safety guidelines and precautions set forth by the governor and health dept. are followed (50 people at time, face masks, 6' social distancing, etc.) for gatherings the event could be held. The date to be determined.
- Rev. Jan Johnson Retirement: Rev. Jan Johnson, a former Interim pastor here at St. John's after Rev. Reinwald retired, has retired. She has asked that any monetary gifts for this milestone be given to the OCWM instead of to her. She will be sending a letter with this request. The council decided to put this announcement in the CHIMES and "bulletin" with a request that donations be sent in with a notation of "Jan Johnson Retirement-OCWM" in the memo line. A Deadline date will be given.
- Blood Drive Site: The Red Cross has
  designated St. John UCC as an approved site
  on an ongoing basis. There was one location
  in Lincoln which canceled their scheduled
  date, so they decided to offer the designation
  to the church. Look for future blood drive
  dates at the church.

#### Other:

• Veteran's Celebration Committee: They met on Monday, July 13. Jan Hahn, chair, and the committee decided to remove names of people from the invitation list who have not responded to the invitation three years or more in a row. Also, anyone who has signed up, but not attended in the last three years will be removed from the list. This will cut down on the postage costs spent to send those invitations in which we receive no response. After some discussion is was also decided that because no fund raising can or could be done and for safety

reason due to Covid-19, that the 2020 Veteran's Celebration will be canceled.

 Rotary Meeting Location Request: At this time since the church services are not convening, no Rotary meetings will be considered. We can look at this at a later date, if they still need a meeting location.


CORRESPONDENCE AND E-MAILS: The Illinois Conference sent a "Thank You" for the church's OCWM annual pledge goal of \$14,200.

#### ADJOURNMENT AND BENEDICTION



# THE ILLINOIS CONFERENCE WELCOMES THE REVEREND MOLLY CARLSON AS OUR NEW CONFERENCE MINISTER!



A graduate of The College of Wooster with a BA in mathematics and Pacific School of Religion with a Master of Divinity, Rev. Carlson brings a wide range of experience to the position of Conference Minister. She has been ordained

within the Christian Church (Disciples of Christ) for 19 years and has held Ordained Ministerial Partner Standing with the United Church of Christ for the last 8. Molly's service in a variety of contexts, including local, regional, and national settings of the church, has taken her to Indiana, California, South Dakota, Oregon, and Tennessee. She has served as an interim minister, church planter, solo pastor, head of staff, and church consultant.

Currently, Rev. Carlson is serving as Intentional Interim Minister at Eastwood Christian Church in Nashville, TN, after completing her term as Designated Term Conference Minister for the Central Pacific Conference of the United Church of Christ. Molly's commitment to lifelong learning is evidenced by her recent training as a professional coach, as well as with The Art of Hosting. She also completed all the requirements toward her DMin at Lexington Theological Seminary, including a final project titled "Creating Church in a Postmodern Context." The following statement from Rev. Carlson's ministerial profile speaks to the passion she brings to her work: I have a passion for middlejudicatory ministry. It is the big picture and the

details. It is leadership and community building. It is networking and recruiting. It is conflict management and corporate celebration. It is administration and proclamation. It is fundraising and event planning. It is being a pastor to pastors - and their families. It is supporting congregations in transition. It is equipping congregations to do more together than any can do alone. It is building a community of faith that celebrates, grieves, supports encourages, and learns from one another. [...] I believe there is an urgent need for the progressive church and the good news of Jesus Christ for this time and place – in every church, in every community, in each and every one of our neighbors.

Molly grew up as a preacher's kid in northwest Indiana. She stayed in the Great Lakes Region for college, followed by a management role with Ameritech (now, again, AT&T). She and Michael have been married for 23 years and are proud parents to teenagers, Sierra and Adam. They have three dogs, a whole lot of books, and are looking forward to making a home once again near the Great Lakes.

Rev. Carlson was recommended to the Illinois Conference Personnel Committee and then the Conference Council by the Conference Minister Search Committee after a nationwide search that included a pool of several exceptional candidates. Molly's election by the delegates of the Illinois Conference at the Annual Meeting (held virtually via YouTube, Zoom, and SurveyMonkey), was culminated today, Saturday, June 27<sup>th</sup>, with a 99% affirmative vote. We are excited that Molly will be able to start her ministry in the Illinois Conference on August 1<sup>st</sup>, and we look forward to partnering with her as we move forward together as the Illinois Conference!

Lincoln Community will host the Red Cross Blood drive on Wednesday, August 26<sup>th</sup> at St. John United Church of Christ in Lincoln from 12:00 noon - 5:00 p.m. Due to the Coronavirus Disease and the precautions to keep all safe there will be new rules at this Bloodmobile.

- 1. Your temperature will be taken first thing before going any further.
- 2. You will be asked to wear face masks at the blood drive. You can wear your own mask/ covering that covers both their nose and mouth in accordance with CDC guidelines. If you don't have a mask Red Cross will provide one. If a donor does not want to wear a mask, we ask they postpone their donation for a later date. It is our job to keep you the staff and everyone as safe as possible. PLEASE HELP US BY WEARING THE MASK.
- To help manage donor flow and social distancing at the bloodmobile you will need to make an appointment to help manage donor flow. Walk-ins will not be accepted. PLEASE KEEP YOUR APPOINTMENT TO HELP OTHERS WHO NEED THIS LIFE SAVING GIFT.
