Census2020 update

Article I Section 2 of the U.S. Constitution specifies the census: "The actual Enumeration shall be made...of the United States...every subsequent Term of ten Years, in such Manner as they shall by Law direct." The first census in 1790 found a U.S. population of 3,929,214. The 2010 census saw 308,745,538 residents.

Why does Census participation matter?

Census numbers are used to determine:

- The drawing of federal, state, and local legislative districts, and the apportionment of representatives a community has. Illinois continues to lose out so every person counts!
- ✓ Prospective businesses study census data before ever contemplating a relocation or a start
- ✓ Where & how much the government invests depends upon where people live and how many live there
- ✓ Societal and economic studies of the U.S. and its people are all relied upon the Census data
- ✓ Distribution of over \$675 biliion annually in federal funds and millions more in state funds spent on:
 - Public aid & anti-poverty programs
 - Schools
 - Public safety
 - Transportation
 - Development of rural areas
 - Farm aid
 - Distribution of vaccines and health services
 - Emergency & disaster funding
 - Housing assistance

Every 10 years, the U.S. Census Bureau is required by the Constitution to count all of the nation's residents. The goal of the 2020 Census is to count every person living in the United States. Data from the census impact everyone including:

What's new with Census in 2020?

- ✓ This the first digital census. Instead of the traditional paper form, the vast majority of the population will be asked to take the Census online using a 16-digit pin or QR code. The site will be available on mobile devices or via a home computer.
- With the ease of census input, the Census Bureau will hire fewer enumerators to go door-to-door after initial mailouts. Staff will only make half as many attempts to visit each home than in previous Census.
- New protections have been put in place to ensure security of information for those worried about census information will be shared.
- ✓ The Census will be available in 13 different languages.

When will the Census counting take place?

In mid-March most addresses in the U.S. will receive a mailing with instructions to participate online, but you will also have the option to respond via phone or mail. People are asked to respond **how many people reside in that household as of April 1, 2020.** Then in early summer, Census Bureau employees will follow up in-person at any addresses that have not yet been received from.



How will census non-participation directly affect our community?

- Local governments rely heavily on block grant funding dollars from the state and some federal dollars, which is impacted by the census.
- ✓ Each person not counted equates to a loss of approximately \$2,000 in funding per year
- CAPCIL here in Logan County has stated that nearly all the funding they receive is derived from census data. Thus less reported population means less people being helped in many vital ways in our community.
- People who rely on government funding the most are often the some of the very individuals who are the least responsive to completing census information.
- Congressional and state legislative representation is based on census data. Our county and state is likely to see a shift in representation and electoral power.
- ✓ Our state, county, and city continue to slip in population. Both our state and county are projected to decrease in population by 3-5% or more. We need all the pu



to decrease in population by 3-5% or more. We need all the numbers we can!

Next steps: what are we taking locally to encourage participation?

- ✓ The U.S. Census Bureau has encouraged the formation of complete count committees in as many communities nationwide as possible. In cooperation with Census officials, a city of Lincoln/Logan County Complete Count Committee has been formed to promote the census and to help identify and target undercounted populations in our area. Our city/county committee is comprised of local media representatives, school officials, library directors, the ministerial association, and Community Action.
- ✓ We will also be partnering with Farm Bureau, Veterans Assistance, Health Department, ALMH to help educate, encourage, and engage participation.
- The US Census Bureau will shortly begin launching several targeted initiatives to help local CCCs in their work. The first of these is the Statistics in Schools program, and we will be working with area schools to educate on the importance of the Census.
- We will be conducting a special Group Quarters Count informational session in Logan County. Group Quarters is the institutional based count, including prisons, retirement homes, and college dormitories.
- ✓ We are activily recruiting local people to be trained enumerators, data assembly clerks, and field supervisors. Logan County has one of the lowest response rates of any county. It pays \$17.50 per hour. If interested, apply at <u>https://2020census.gov/en/jobs</u>.

Things to keep in mind:

- People increasingly distrustful of government are concerned about sharing their information or living situations with other entities. Federal law ensures that Census responses can only be used to produce statistical information, and personal information cannot be seen by other government agencies or the courts. Census Bureau employees are sworn to uphold the confidentiality of data for life, and U.S. Code imposes steep penalties for anyone who shares personally identifiable information.
- The Census Bureau seeks to count all people residing in the United States at their usual residence, which is the place where they live and sleep most of the time, (or where they are present if no home), on <u>Census Day, which is April 1, 2020</u>.
 - Children in shared-custody are counted where they live and sleep most of the time. In cases
 of equally-shared custody, children are counted where they are present on April 1, 2020.
 - Non-Citizens if they are living in the U.S., they will be counted at their usual residence.
 - Active military personnel and families, if they are stationed at a military installation in the U.S., they will be counted at their usual residence either on-base or off-base.
 - College students living on campus or in off-campus housing will be counted at school facilities or at their off-campus housing. If they are attending a school outside the U.S. and living abroad, they will not be counted.
 - Incarcerated persons will be counted at the prison or iail in which they are incarcerated on April 1 2020
