

May 2020

Report Summary

Social distancing is a critical practice that is essential to help prevent COVID-19 from spreading. The best way to practice social distancing is to avoid public places and to maintain a distance of at least six feet between you and others. In addition, practice frequent handwashing and cleaning of commonly-touched surfaces. If you are sick or have symptoms such as cough, fever and shortness of breath, call your medical provider. Lincoln Police responded to 762 incidents for the month and 93 case reports were written for the month. Officers responded to 19 vehicle crashes. Patrol officers wrote 45 citations and 25 warnings for the month, along with 1 City Ordinance Citation and 1 City Cannabis Ordinance Citation.

Of the 42 arrests for the month, officers arrested several for domestic battery, driving while suspended/revoked, warrants and methamphetamine possession. Detectives continued investigations on 9 cases including participating in CIEG task force operations.

The K9 unit had 5 deployments for the month of May. Out of those deployments, Officer Sullivan and ACE made 1 arrest and indicated on 2 deployments. The items indicated were drug paraphernalia and cannabis related.

DARE has been able to provide children with bicycles. Graue Chevrolet has decided to refurbish old bicycles and donate them to children of the community. Officer Fruge is helping out in the distribution aspect.

Due to the current Shelter in Place Order, that the Governor enacted on March 13th, our two SRO officers are not able to work in the schools at the moment. They have been patrolling the streets to help their fellow officers with the influx of calls of service.

There were 19 crashes the Lincoln Police Department responded to for the month of May.




MONTHLY STATISTICS


Uniform Crime Reporting (UCR)

UCR Report for May 2020











DIVISION REPORTS

Criminal Investigations

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on $\underline{9}$ active criminal investigations in the month of May. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available to for release.

- (2) Investigations were narcotics related.
- (2) Investigations involved sexual offenses.
- (3) Investigations involved crimes against persons.
- (2) Investigations were property related.
- (1) Search warrants were executed to further the above investigations.
- Two officers of the Criminal Investigations Division continued to participate in a multijurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.

DARE/Community Policing

Chris Graue, from Graue Chevrolet, is working with Officer Christy Fruge with helping the community by having his service department repairing bicycles to give back to children in the community. The mechanics are repairing, replacing parts and painting bicycles that have been donated by people, due to the bicycles being old and/or needing repair. Graue then contacts Officer Fruge to distribute the bicycles to children in the community, with guidance from local teachers and school resource officers.

Lincoln K9

Officer Sullivan and K9 Ace had 5 deployments for the month of May. The deployments resulted in 2 people being found, 1 arrest and 2 indications. The indications were drug related. The drug paraphernalia and drugs seized were cannabis related.
