# Monthly Report

September 2020

## Report Summary

Social distancing and wearing a mask are critical practices that are essential to help prevent COVID-19 from spreading. The best way to practice social distancing is to avoid public places and to maintain a distance of at least six feet between you and others. Lincoln Police responded to 922 incidents for the month and 123 case reports were written for the month. Officers responded to 30 vehicle crashes. Patrol officers wrote 47 citations and 26 warnings for the month, along with 6 City Ordinance Citation and 2 City Cannabis Ordinance Citation.

Of the 49 arrests for the month, officers arrested several for domestic battery, warrants, unlawful possession of controlled substance, retail theft, and driving while license suspended. Detectives continued investigations on 26 cases including participating in CIEG task force operations.

The K9 unit had 2 deployments for the month of September. K9 ACE had 2 indications. The indicated items seized were drugs, being methamphetamines and cannabis along with drug paraphernalia.

DARE was able to help support the Ryan Williams' Memorial Playground Fund for Washington-Monroe School. It will help Washington-Monroe build a wonderful playground for the students and all the children in the community. DARE has wonderful supporters that help our young members of our community.

SRO officers have more responsibilities due to COVID-19 for this school year.

There were 30 crashes the Lincoln Police Department responded to for the month of September.

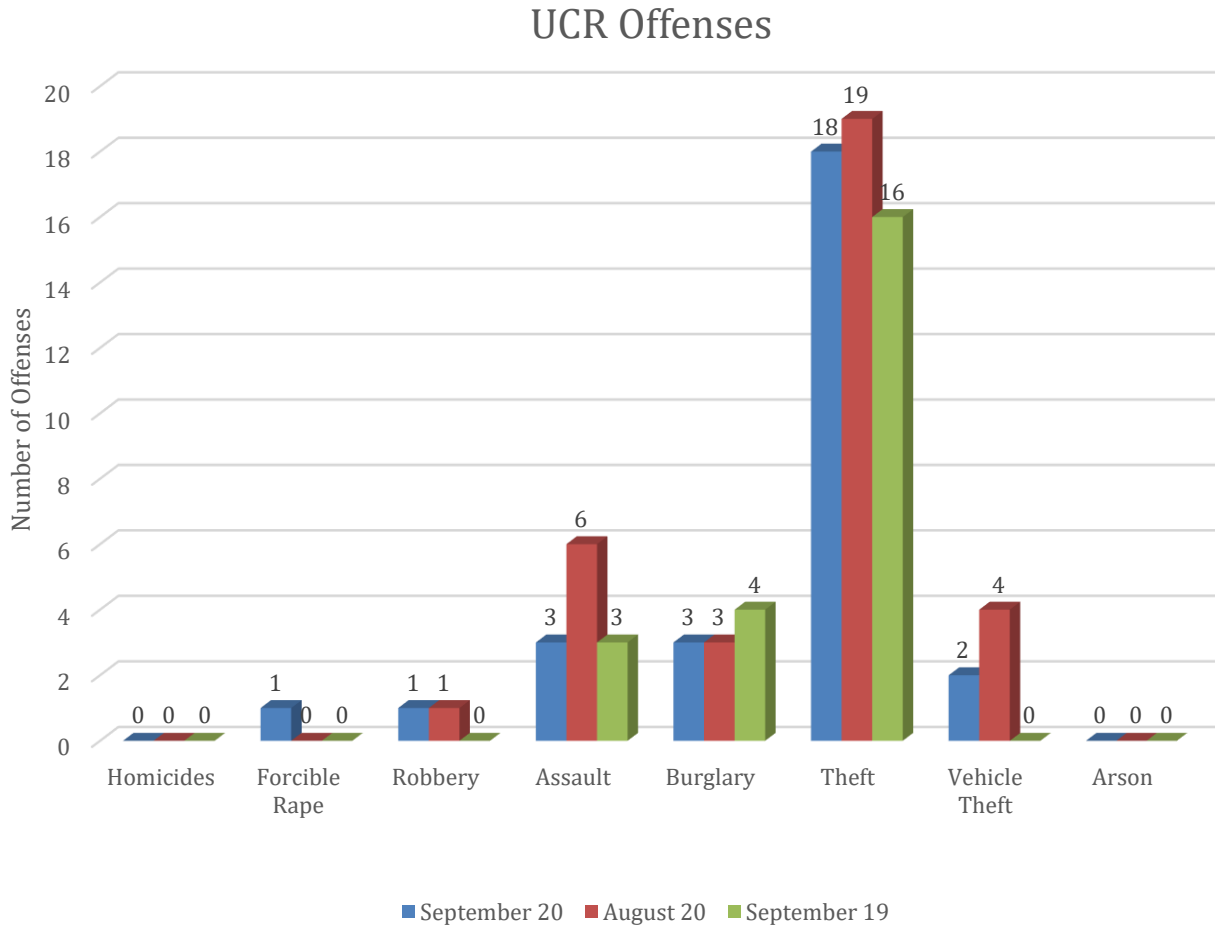

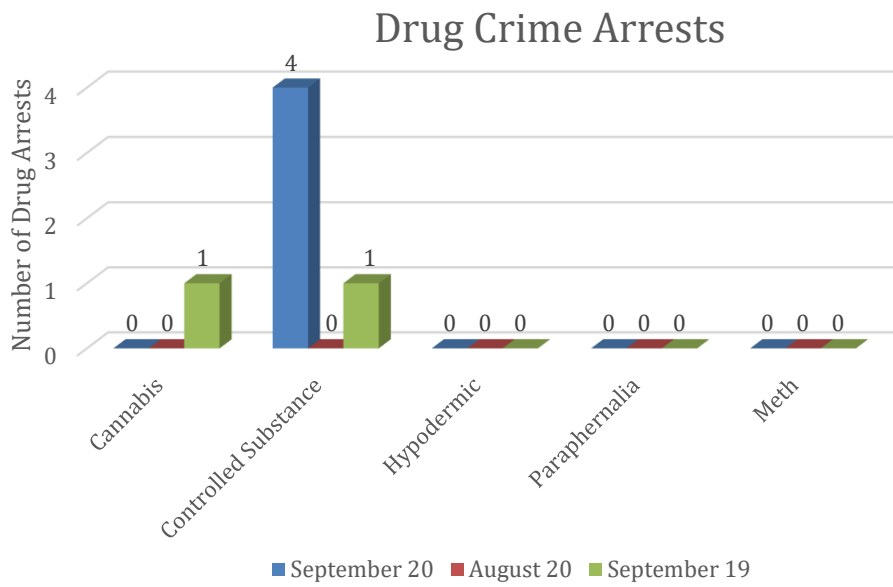
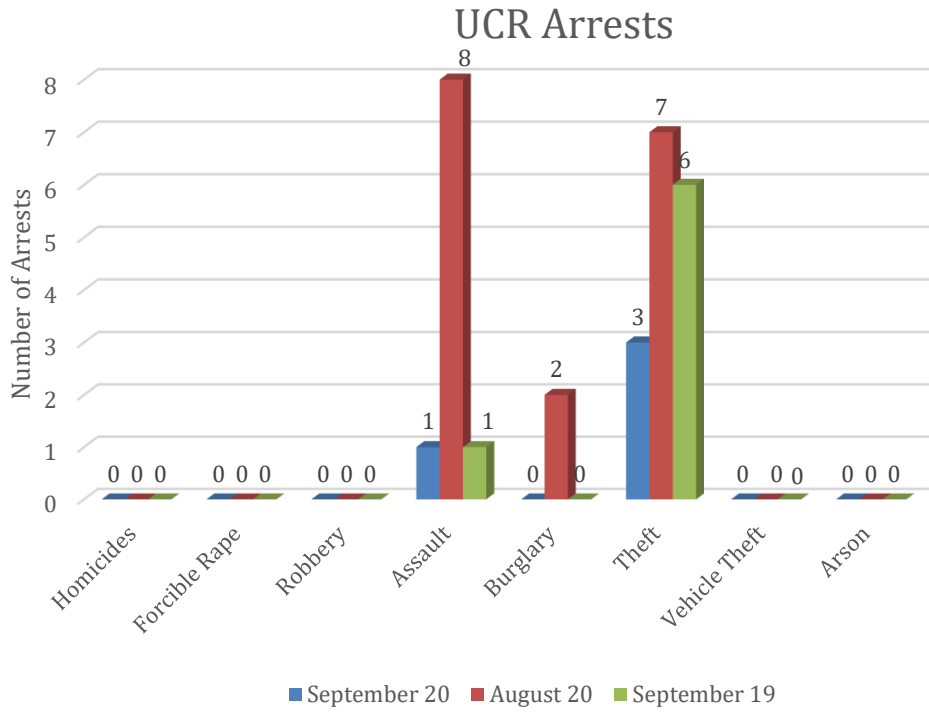
# MONTHLY STATISTICS

### UCR Report for September 2020





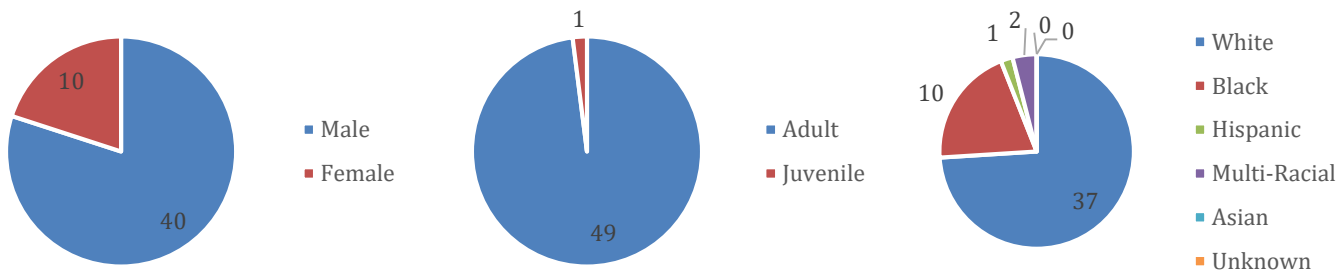

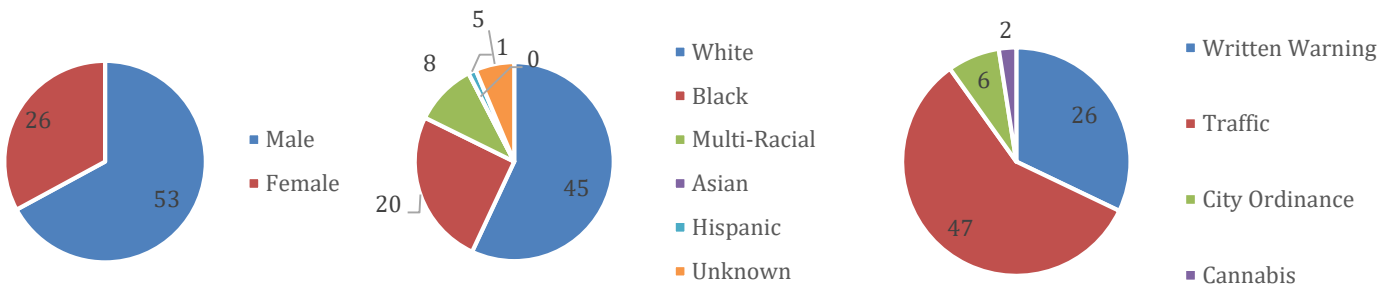

### Criminal Investigations

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on 26 active criminal investigations in the month of September. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available to for release.

- (10) Investigations were property related.
- (1) Search warrants were executed to further the above investigations.
- Two officers of the Criminal Investigations Division continued to participate in a multi-jurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.
