Report Summary

Social distancing and wearing a mask are critical practices that are essential to help prevent COVID-19 from spreading. The best way to practice social distancing is to avoid public places and to maintain a distance of at least six feet between you and others. In addition, practice frequent handwashing and do not touch your eyes, nose or mouth. If you need to get tested or are wanting to get the vaccine, please go to the Logan County Health Department's website for testing and/or vaccination sites and times.

Lincoln Police responded to 766 incidents for the month and 80 case reports were written for the month. Officers responded to 25 vehicle crashes. Patrol officers wrote 55 citations and 22 warnings for the month along with 1 City Ordinance Citation.

Of the 51 arrests for the month, officers arrested several for domestic battery, violation of order of protection, driving with suspended/revoked drivers license, retail theft and warrants. Detectives continued investigations on 20 cases including participating in CIEG task force operations.

The K9 unit is very beneficial to the Lincoln Police Department and the community. They had 5 deployments for the month of February.

DARE was able to help children with clothing and supply needs this past month. DARE started it's fundraising in February.

The goals of well-founded SRO programs include providing safe learning environments in our community's schools, providing valuable resources to school staff members, fostering positive relationships with youth, developing strategies to resolve problems affecting youth and protecting all students, so that they can reach their fullest potentials. The three main roles of school resource officers are: educator (i.e. guest lecturer), informal counselor/mentor, and law enforcement officer.

There were 25 crashes the Lincoln Police Department responded to for the month of February.

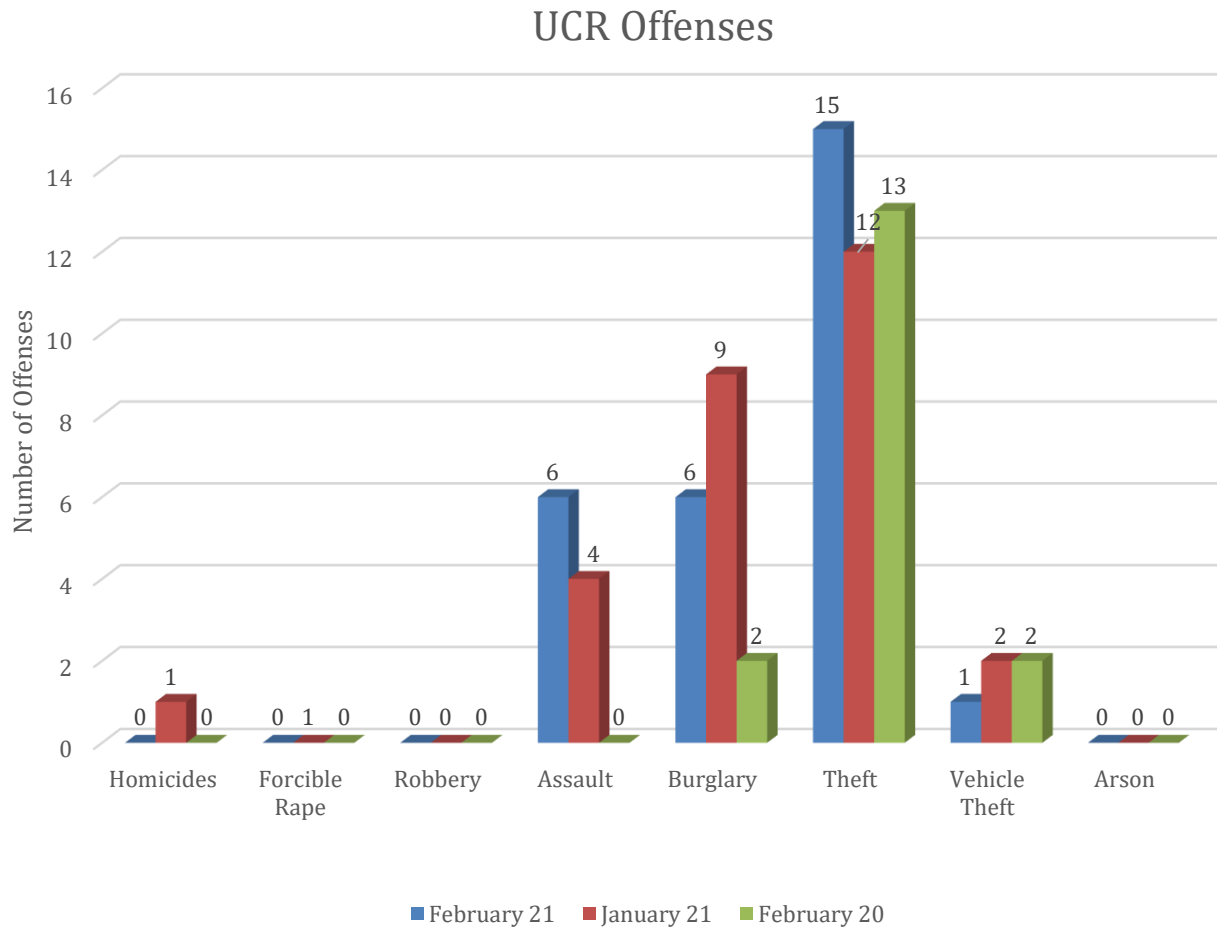

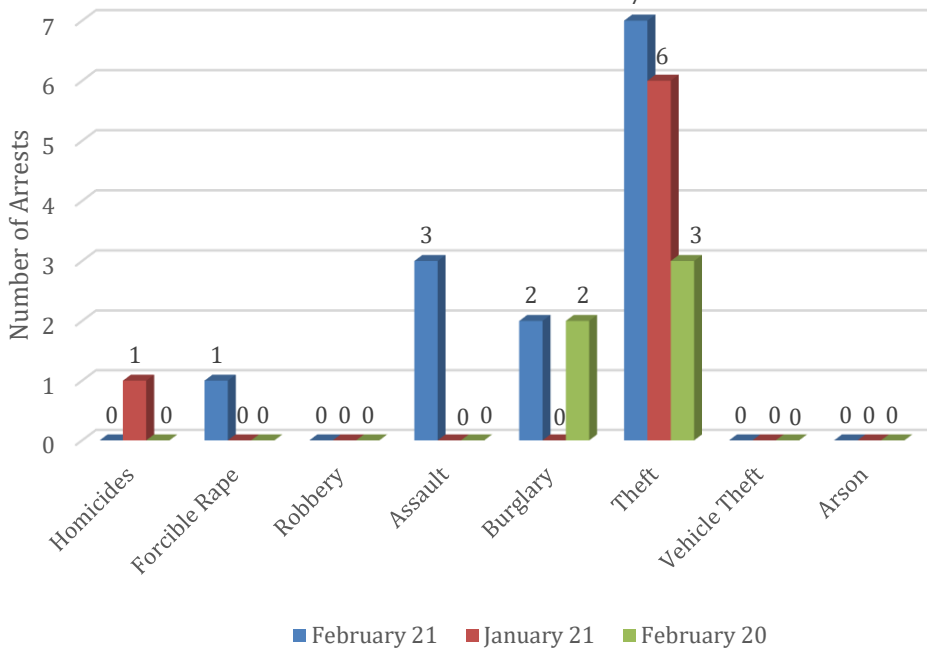
Uniform Crime Reporting (UCR)

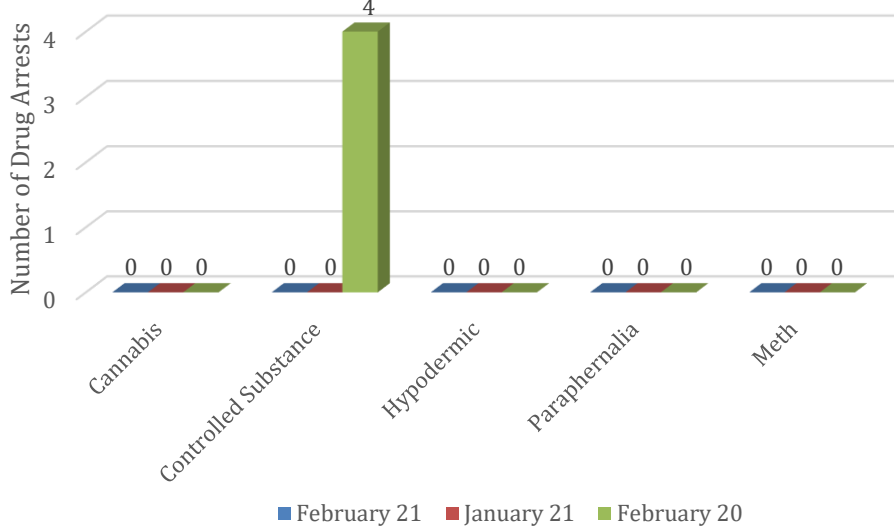
UCR Report for February 2021

Drug Crime Arrests



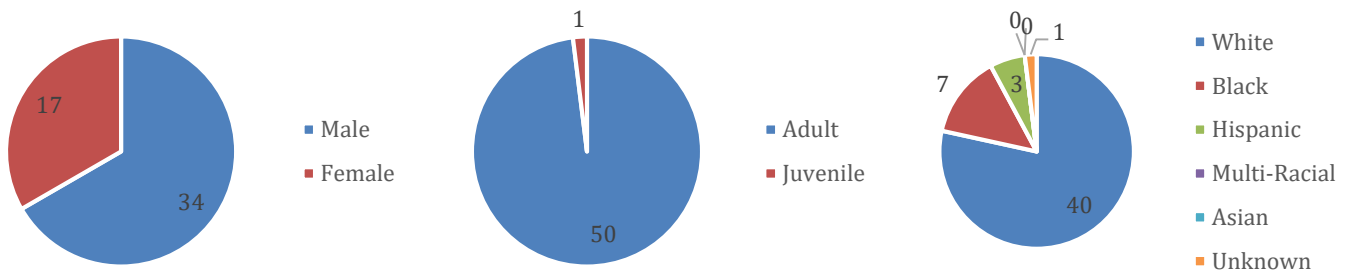

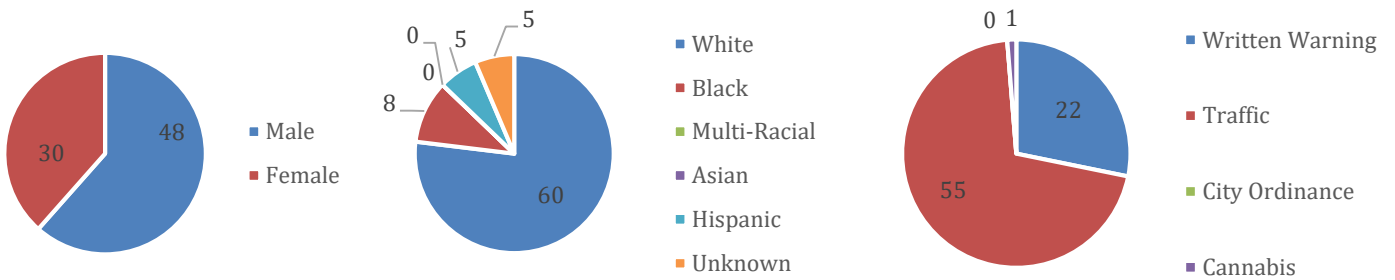

DIVISION REPORTS

Criminal Investigations

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on 20 active criminal investigations in the month of February. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available to for release.

- (7) Investigations involved sexual offenses.
- (5) Investigations involved crimes against persons.
- (6) Investigations were property related.
- (2) Investigations were narcotics related.
- Investigators executed 1 search warrant.
- The criminal investigation division saw a continued increase in property related crimes in the month of February.
- Two officers of the Criminal Investigations Division continued to participate in a multi-jurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.

DARE/Community Policing

DARE was able to help buy shoes and clothing for multiple children in the month of February. DARE and the Lincoln Fraternal Order of Police, which includes all the officers on the Lincoln Police Department, have been working with the teachers in the Lincoln School Districts and the Lincoln High School, obtaining names of children that are in need of clothing and/or shoes. With the pandemic and cold temperatures, we need to make sure that our young population are receiving necessities that will help them achieve greater things. Officer Fruge started the fundraising in February so that DARE can buy the books and supplies for the DARE Training Classes starting in March.

Lincoln K9

Officer Sullivan and K9 Ace had 5 deployments for the month of February. The deployments resulted in a building search and vehicle searches with indications of cannabis and drug paraphernalia.

School Resource for LCHS and District #27

Our School Resource Officers are always putting forth the positive attitudes that the kids are needing in these uncertain times. Always remember that the SRO's are there for your students if they need that ear to listen to them or just have questions they need answered.

The three main roles of school resource officers are: educator (i.e. guest lecturer), informal counselor/mentor, and law enforcement officer.

Officer Butterfield reported that the kids, at the high school, are getting use to the routine of how the school day is structured. The most common incidents that Officer Butterfield responded to were general class misconduct, harassment/bullying, and parking issues.

Officer Fruge reported that the kids, at district #27, are getting comfortable with the routine of their school day. The most common incidents that Officer Fruge responded to were general counseling issues and harassment/bullying issues.
