CITY OF LINCOLN

ORDINANCE NO. 2022-

AN ORDINANCE FOR THE LEVYING OF TAXES FOR ALL CORPORATE PURPOSES, IN FOR THE CITY OF LINCOLN, ILLINOIS, FOR THE FISCAL YEAR BEGINNING MAY 1, 2022 AND ENDING APRIL 30, 2023.

BE IT ORDAINED by the Mayor and City Council of the City of Lincoln, Logan County, Illinois: SECTION 1: That the amount hereinafter set forth, or so much be authorized by law, and the same are hereby thereof levied upon all property subject to taxation within the municipality as that property is assessed and equali current year, and for such purposes as General corporate, Police Protection, Fire Protection, Streets and Alleys (Streets & Bridge), Audit, ESDA, Forestry, Liability Insurance, IMRF-Soc. Security, Public Benefits, Crossing Guards, Debt Service, Sewerage O. & M. (Chlorination), Police Pension, Firemen's Pension and Firemen's Spouse Benefit for the City of Lincoln, Logan County, Illinois, for the fiscal year beginning May 1, 2022 and ending April 30, 2023. 




Section 3: That the City Clerk shall make and file with the County Clerk of said County of Logan on or before the last Tuesday in December, a duly certified copy of this ordinance.
