Drug Take Back

On Saturday, September 29, staff from Abraham Lincoln Memorial Hospital and the Lincoln Police Department teamed up at the new Lincoln Police Station to collect unused and expired medication. Those that dropped off more than 1 pound of medication were entered into a drawing for three \$100 gift cards. In total we collected about 80 pounds of medication. If you missed dropping off medication during this day, the Police Station has a convenient drop off box located near the front door.

Officer Christy Fruge also had the brand new DARE grill fired up to serve hotdogs. The new grill was sponsored by Graue Chevrolet and Lincoln Chrysler Dodge Jeep dealership.

All the drugs collected during the day were burned that same day at the Lincoln Police incinerator that was donated by ALMH Foundation.

This was all in an effort to support the goals established by the Logan County Opioid Taskforce!

There were 28 crashes the Lincoln Police Department responded to for the month.

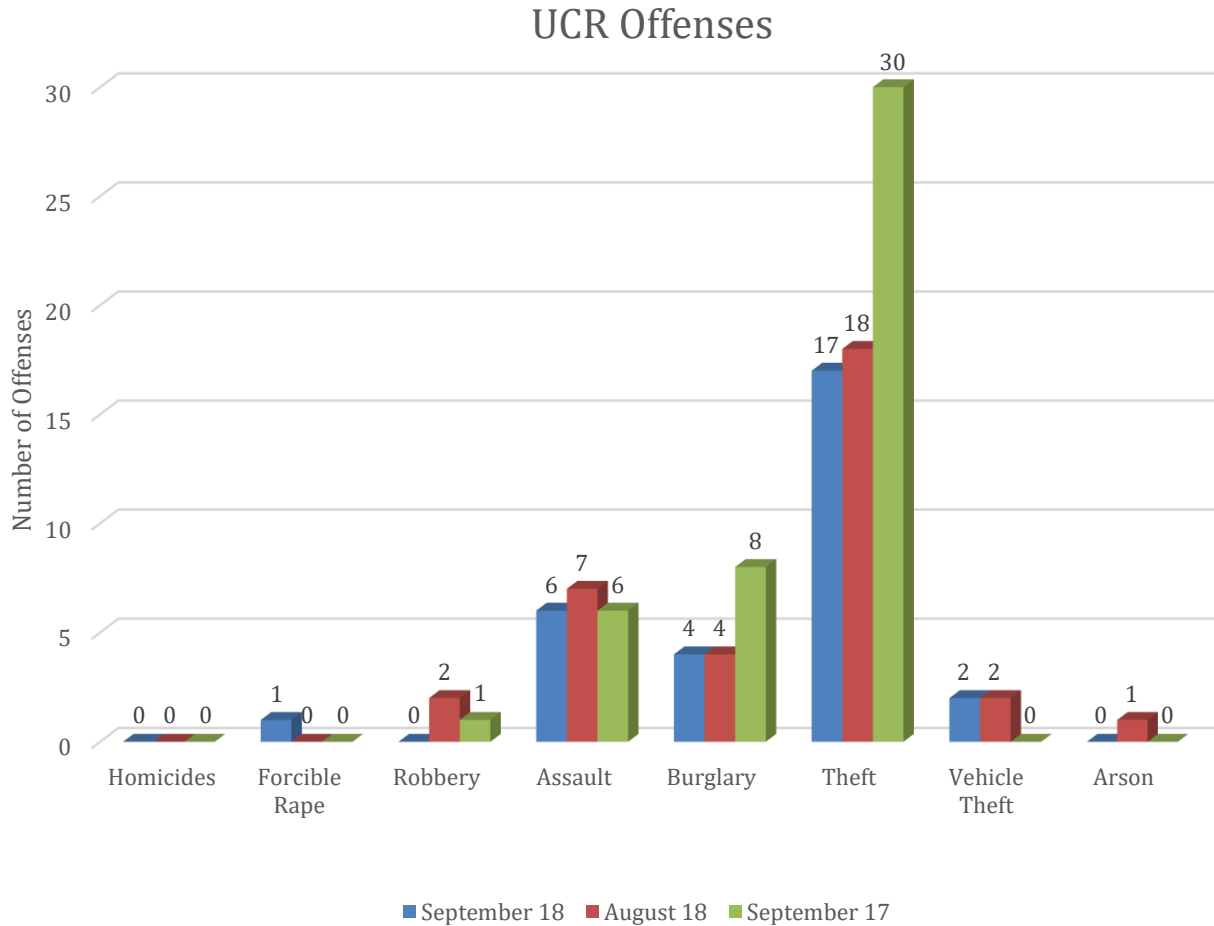

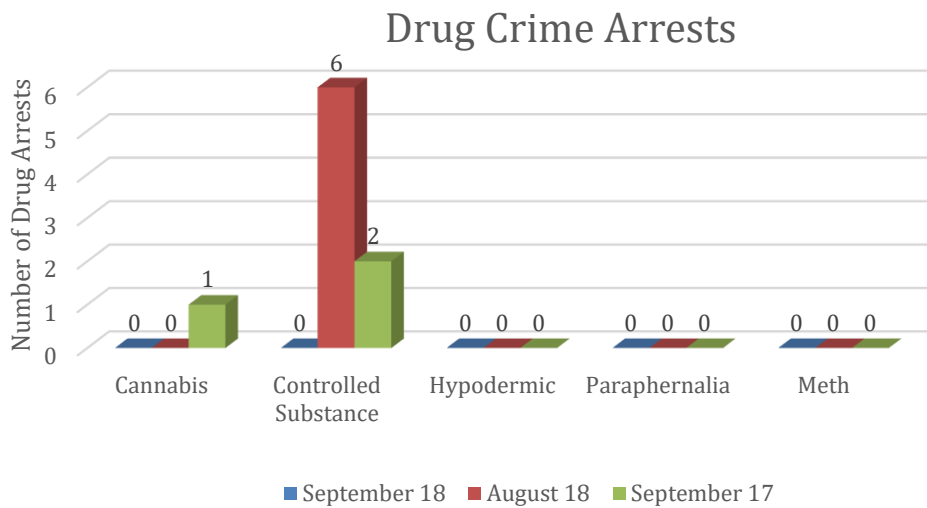
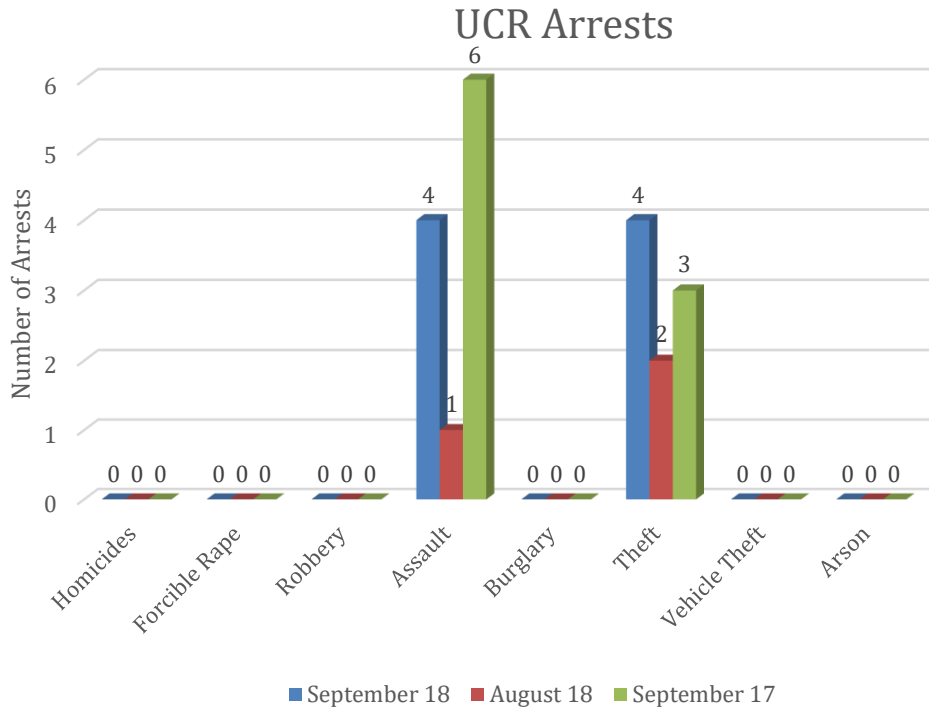
MONTHLY STATISTICS

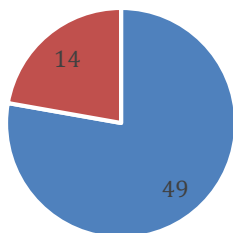
Lincoln Police responded to 1256 incidents for the month of September and 123 case reports were written for the month.

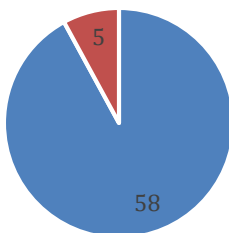

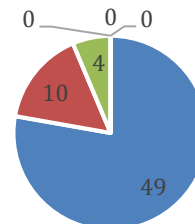

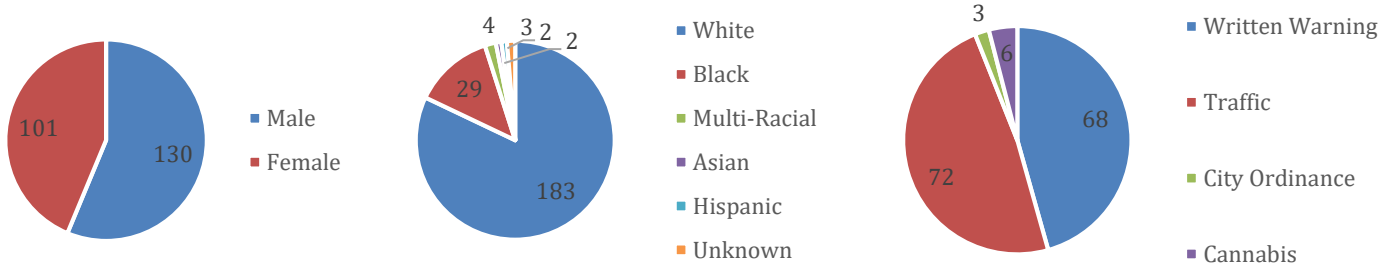

Criminal Investigations

Monthly Cases Report Summary for September 2018

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on 22 active criminal investigations in the month of September. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available to for release.

- (11) Investigations were narcotics related. These cases involved the manufacture/delivery of a controlled substance, production of cannabis and the manufacture/delivery of methamphetamine.
- (5) Investigations involved sexual offenses. These crimes involved both adult and child victims with offenses of predatory criminal sexual assault, criminal sexual assault and criminal sexual abuse.
- (3) Investigations involved crimes against persons. These investigations involved, drug induced aggravated battery, aggravated discharge of a firearm and attempted murder.
- (3) Investigations were property related crimes. These cases involved fraud, burglary, and criminal damage to property.
- Two officers of the Criminal Investigations Division continued to participate in a multi-jurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.
- (7) Search warrants were executed in furtherance of these investigations.

DARE/Community Policing

September 29th: Lincoln teamed up with members of the heroin task force and Abraham Lincoln Memorial Hospital to have a drug take back day. Lincoln DARE provided \$100 gift cards to 3 lucky citizens who brought in over a pound of unused medication.

During the event Officer Christy Fruge was on hand with Chief Adams cooking Lunch on the new grill purchased by Lincoln DARE, Graue Chevrolet, Pigs and Swigs, and Lincoln Dodge. Officer Michael Fruge spent the day at the incinerator destroying medications that have been collected in the drop box over the last couple of months and the medications collected the day of the event.

In total we are estimating close to 160 pounds of unused and expired medications were destroyed from the drug drop off box and what was collected that day!

Lincoln K9

Officer Sullivan and K9 Ace had 9 deployments for the month. Lincoln Police Department requested the K9 Unit 7 times and the Logan County Sheriff's Department requested the LPD K9 Unit 2 times. The K9 indicated 7 out of the 9 deployments. Out of the 7 indications, there were 11 items seized being drugs and/or drug paraphernalia. Total amount of drugs seized was 7.5 grams. The drugs indicated were Cannabis along with drug paraphernalia. Officer Sullivan and K9 Ace were also deployed in a Tracking Search, which K9 Ace completed successfully.

School Resource

Officer Butterfield responded to 90 incidents at LCHS for the month of September. The most common offenses were Harassment/Bully issues, class misconduct, Medical, general disciplinary offenses with parental contacts, and Threats to school/staff. Officer Butterfield went over the new Standard Response Protocol with Hartsburg Emden, West Lincoln-Broadwell and the Lincoln College Board of Trustees. Officer Butterfield administrated lockdown drills at LCHS, Zion, Washington-Monroe, Central, CEL and LJHS. Officer Butterfield also administrated an off-site shelter drill at LCHS and a fire drill at LCHS. Officer Butterfield attended the LCHS Board meeting for student Discipline and was the lead in the LCHS Homecoming Parade.
