Opioids

Common questions in regards to Opioids:

1) What is an Opioid?

Opioids are a drug typically derived from the opium poppy plant. Opioids are also now created in labs. Opioids can relax the body and relieve pain by shutting down the pain receptors in the body. They also give a person a feeling of “high” and are extremely addictive. Heroin has been used for years as the most common street drug and has caused millions of deaths.

2) What are some opioid prescription medications?

- hydrocodone (Vicodin®) oxycodone (OxyContin®, Percocet®)
- oxymorphone (Opana®)
- morphine (Kadian®, Avinza®)
- codeine
- fentanyl

3) What is Narcan?

Narcan, or nalaxone, is a drug that can temporarily reverse the effects of opioids. Those suffering from an opioid overdose will stop breathing. Overdose victims can often be saved through the use of Narcan and CPR, however there can be severe damage to the brain due to the lack of oxygen. Medical attention and monitoring is mandatory in any overdose situation as the effects of an opioid will return as the Narcan wears off, typically within 30 minutes to an hour.

4) Why is fentanyl so dangerous?

Fentanyl is a derivative that is created in labs and is 10 times more potent than heroin. Drug dealers are mixing fentanyl with other drugs to enhance their effects which is creating 10 times as many overdoses and deaths. There are other derivatives created in labs that are 100 times more potent that are typically used on elephants and have made it to US streets that are being mixed and causing instant deaths. Even some marijuana and cocaine is being laced with fentanyl causing overdoses.

There were 38 crashes the Lincoln Police Department responded to for the month.

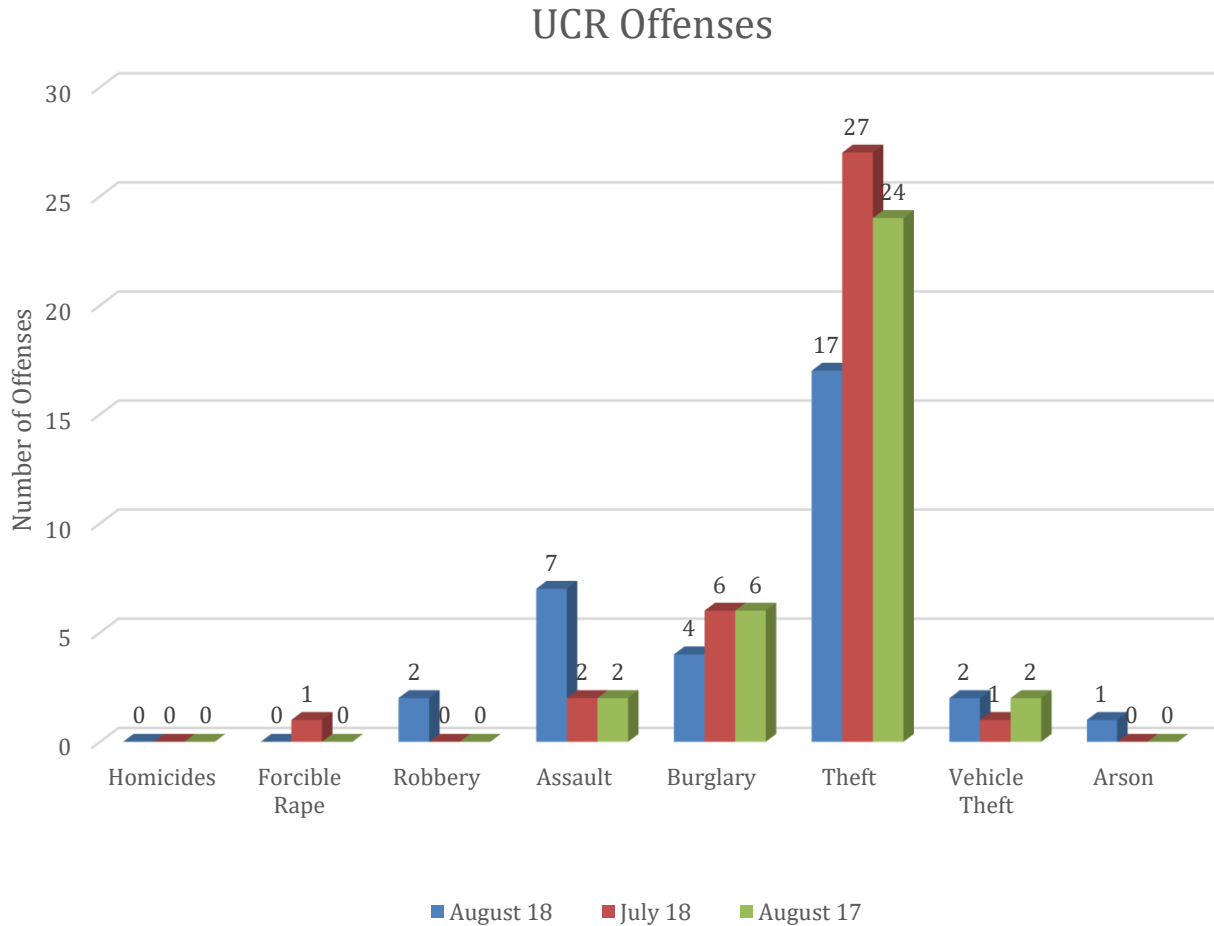

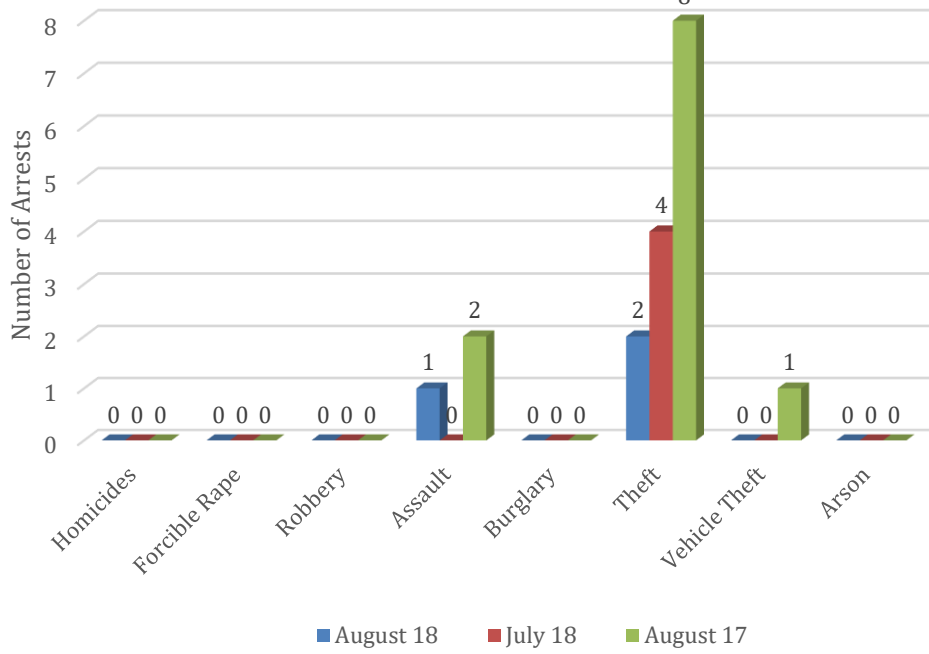
Uniform Crime Reporting (UCR)

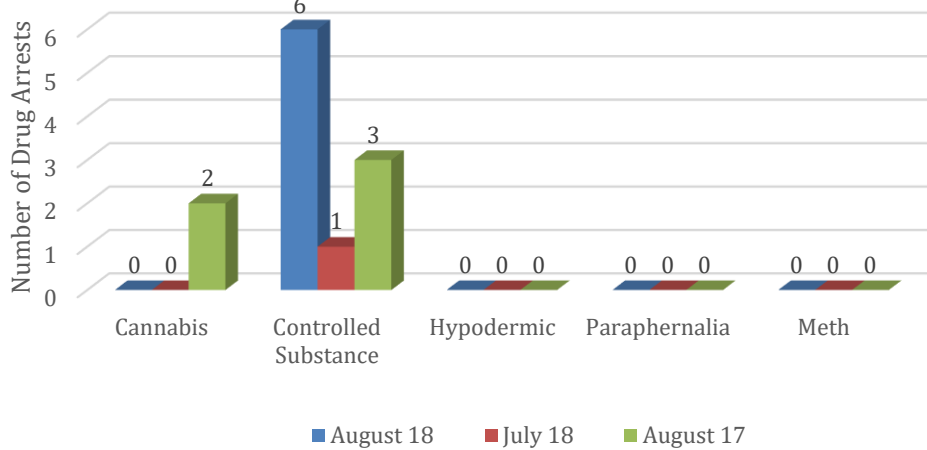
UCR Report for August 2018

Drug Crime Arrests



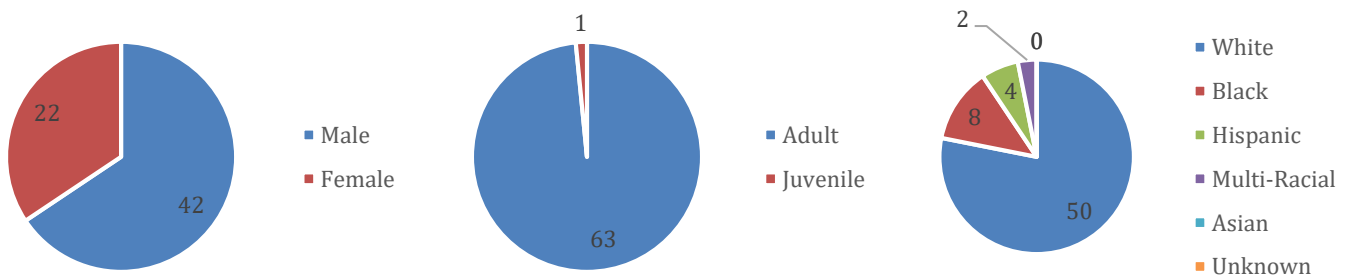
Lincoln Police responded to 1274 incidents for the month of August and 131 case reports were written for the month.

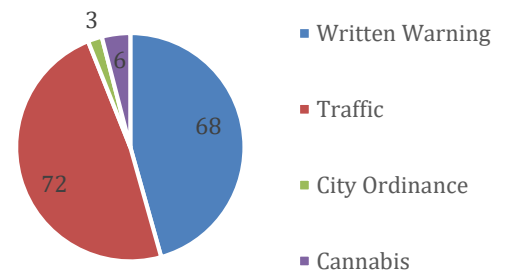
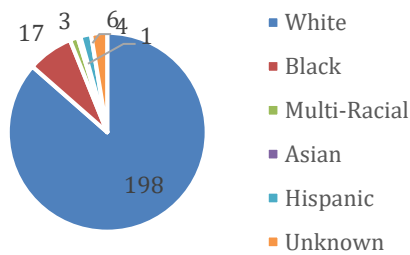
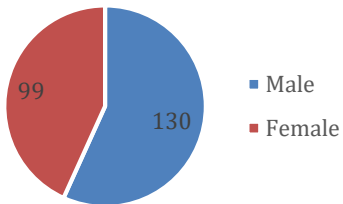

DIVISION REPORTS

Criminal Investigations

Monthly Cases Report Summary for August 2018

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on 22 active criminal investigations in the month of August. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available to for release.

- (6) Investigations were narcotics related. These cases involved the manufacture/delivery of a controlled substance and the production of cannabis.
- (5) Investigations involved sexual offenses. These crimes involved both adult and child victims with offenses of predatory criminal sexual assault, criminal sexual assault and criminal sexual abuse.
- (6) Investigations involved crimes against persons. These investigations involved child abuse, drug induced battery, armed robbery, and aggravated battery.
- (5) Investigations were property related crimes. These cases involved money laundering, credit card fraud, identity theft, forgery, and criminal damage to property.
- Two officers of the Criminal Investigations Division continued to participate in a multi-jurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.
- (5) Search warrants were executed in furtherance of these investigations.

DARE/Community Policing

August 3rd: Lincoln DARE donated \$250 towards the Lincoln Chill girls softball program. The money will help offset the cost for families who have daughters that would like to participate.

August 27th: Lincoln DARE purchased a new towable grill. This grill will be used for picnics in the park events, the fishing derby, the golf outing and many other events and activities.

Area Businesses also donated to help offset the cost of the grill. A future announcement will be made in reference to the grill, along with a free lunch provided by DARE as a thank you.

August 27th: Lincoln DARE donated to the WLB Booster Club for their chicken noodle dinner fundraiser.

Lincoln K9

Officer Sullivan and K9 Ace had 14 deployments for the month. Lincoln Police Department requested the K9 Unit 9 times and the Logan County Sheriff's Department requested the LPD K9 Unit 5 times. The K9 indicated 10 out of the 14 deployments. Out of the 10 indications, there were 7 items seized being drugs and/or drug paraphernalia. Total amount of drugs seized was 7.8 grams. The drugs indicated were Cannabis, Crack Cocaine and Cocaine along with drug paraphernalia. Officer Sullivan and K9 Ace were also deployed in a human and evidence Search. This search resulted in an arrest along with evidence recovered.

School Resource

Officer Butterfield responded to 58 incidents at LCHS for the month of August. The most common offenses were Harassment/Bully issues, class misconduct, Medical, general disciplinary offenses with parental contacts, social/emotional issues and parking issues. Officer Butterfield went over the new Standard Response Protocol with Lincoln College in 6 sessions to cover all staff. Officer Butterfield attended Freshman Orientation to help students coming into LCHS. Officer Butterfield also covered SRP training with LCHS teachers, CEL teachers, Zion teachers and 5 County Head Start Facilities.
