Report Summary

Social distancing and wearing a mask are critical practices that are essential to help prevent COVID-19 from spreading. The best way to practice social distancing is to avoid public places and to maintain a distance of at least six feet between you and others. In addition, practice frequent handwashing and do not touch your eyes, nose or mouth. If you need to get tested or are wanting to get the vaccine, please go to the Logan County Health Department's website for testing and/or vaccination sites and times.

Lincoln Police responded to 847 incidents for the month and 109 case reports were written for the month. Officers responded to 23 vehicle crashes. Patrol officers wrote 54 citations and 45 warnings for the month along with 3 City Ordinance Citation.

Of the 62 arrests for the month, officers arrested several for, driving with suspended/revoked drivers license, domestic battery, warrants, and. Detectives continued investigations on 19 cases including participating in CIEG task force operations.

The K9 unit is very beneficial to the Lincoln Police Department and the community. They had 5 deployments for the month of March.

DARE was able to help children with clothing and supply needs this past month.

The goals of well-founded SRO programs include providing safe learning environments in our community's schools, providing valuable resources to school staff members, fostering positive relationships with youth, developing strategies to resolve problems affecting youth and protecting all students, so that they can reach their fullest potentials. The three main roles of school resource officers are: educator (i.e. guest lecturer), informal counselor/mentor, and law enforcement officer.

There were 23 crashes the Lincoln Police Department responded to for the month of March.

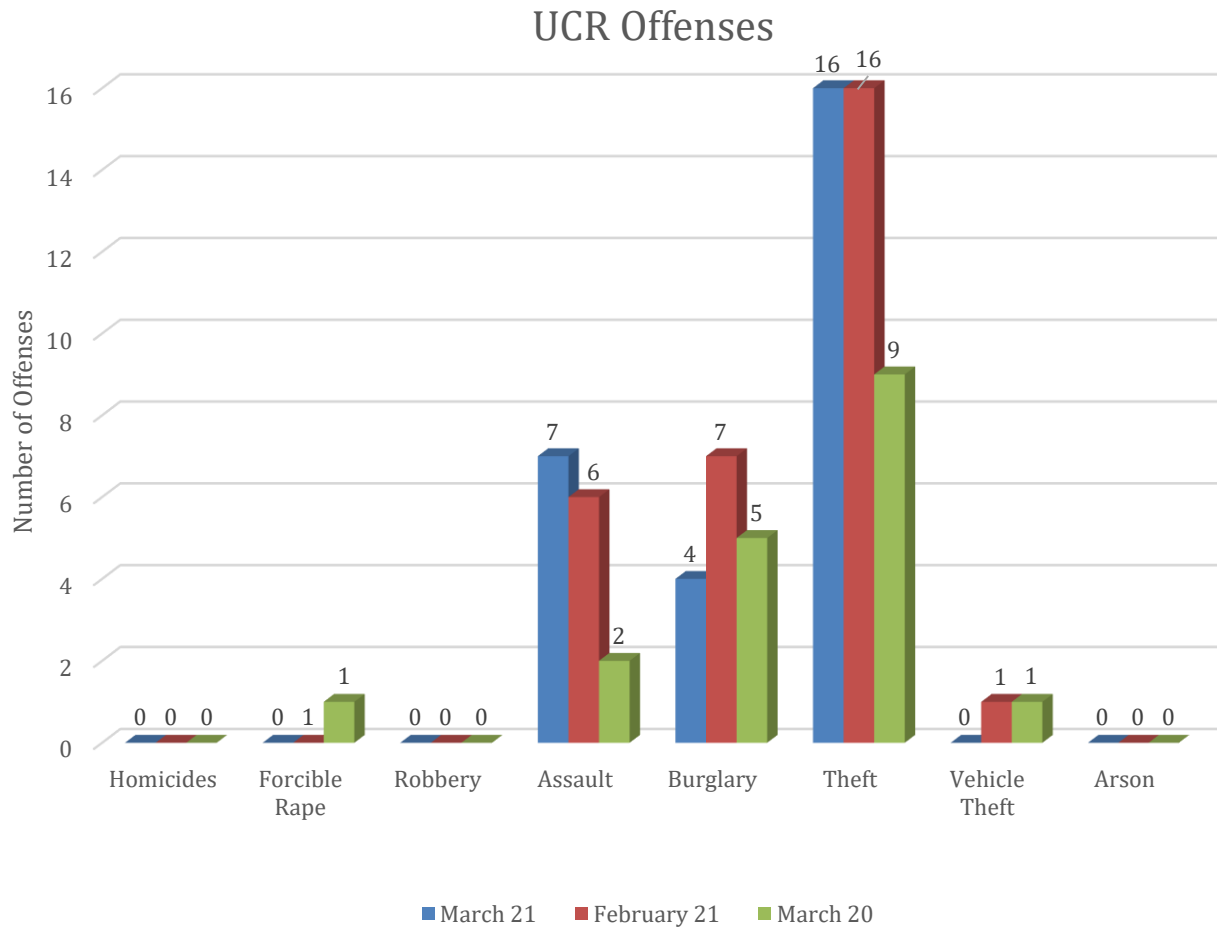

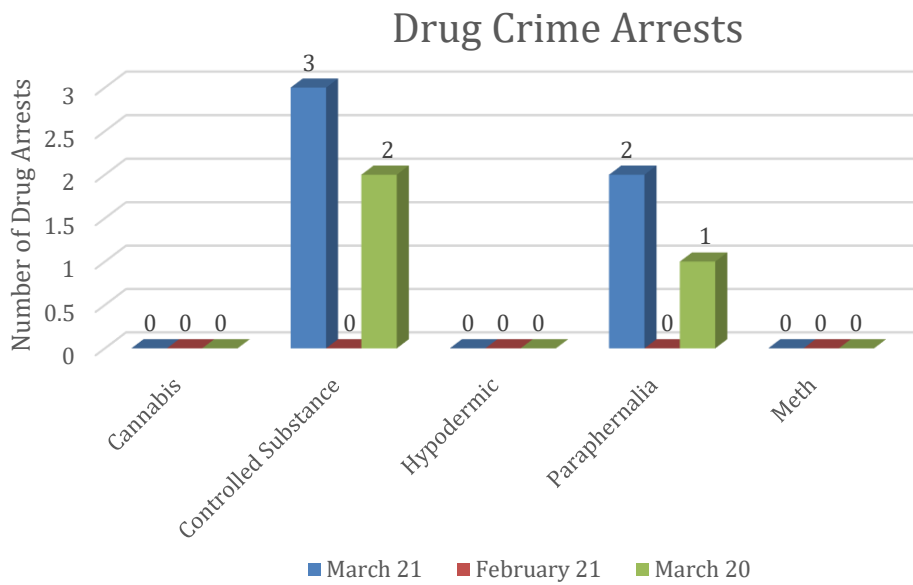
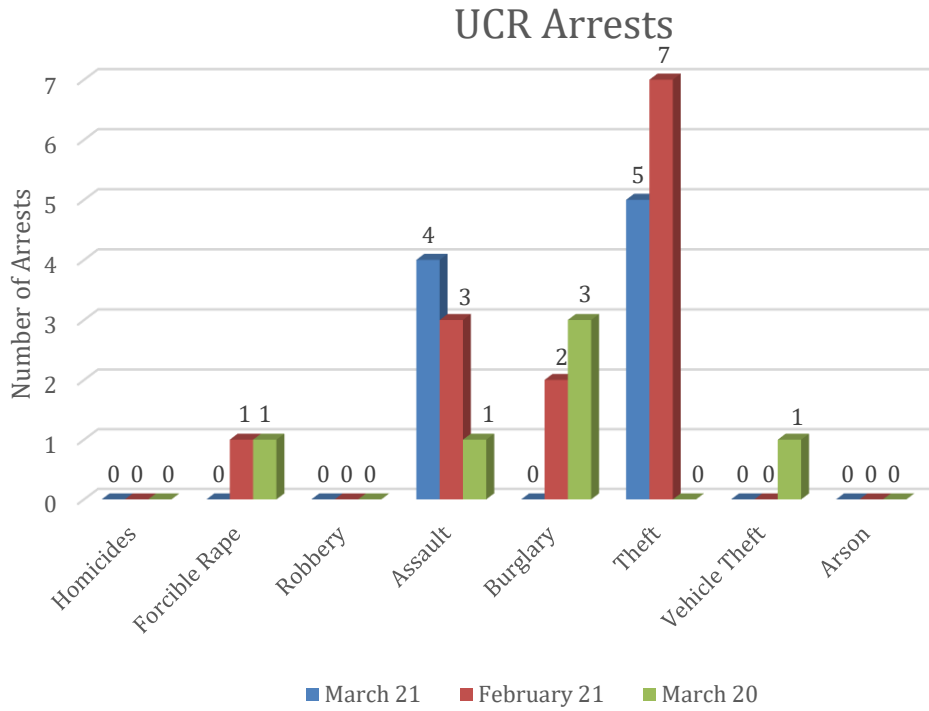
MONTHLY STATISTICS

UCR Report for March 2021





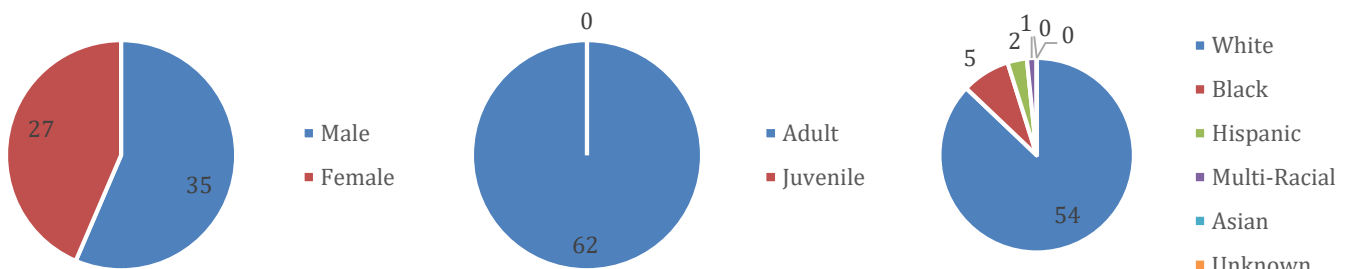
Lincoln Police responded to 847 incidents for the month of March and 109 case reports were written for the month.

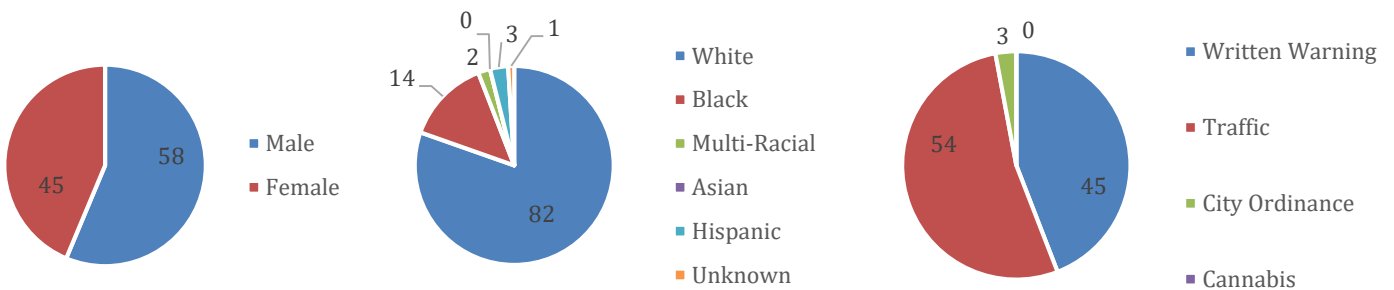

DIVISION REPORTS

Criminal Investigations

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on 19 active criminal investigations in the month of March. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available to for release.

- (5) Investigations involved sexual offenses.
- (7) Investigations involved crimes against persons.
- (6) Investigations were property related.
- (1) Investigations were narcotics related.
- Investigators executed 6 search warrant.
- Two officers of the Criminal Investigations Division continued to participate in a multi-jurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.

DARE/Community Policing

DARE was able to buy a pair of shoes for a child in the month of March. DARE and the Lincoln Fraternal Order of Police, which includes all the officers on the Lincoln Police Department, have been working with the teachers in the Lincoln School Districts and the Lincoln High School, obtaining names of children that are in need of clothing and/or shoes. DARE was able to help The Boy Scout Troop #102, Lincoln YMCA Archery, WLB boosters and the Mt. Pulaski Trap/Skeet team. Wells Firearms hosted a Youth Hunting Course were DARE was able to offer a cookout for donations.

Lincoln K9

Officer Sullivan and K9 Ace had 5 deployments for the month of March. All deployments resulted in vehicle searches with indications of crack and drug paraphernalia with one arrest being made.

School Resource for LCHS and District #27

Our School Resource Officers are always putting forth the positive attitudes that the kids are needing in these uncertain times. Always remember that the SRO's are there for your students if they need that ear to listen to them or just have questions they need answered.

Officer Butterfield reported that the incidents he responded to in March were social/emotional, harassment/bullying, E-Cig/Vape violations and general misconduct that result in parental contacts. Officer Butterfield also trained the employees at Lincoln City Hall, the Lincoln City Street Department, the Lincoln Christian Church and the Lincoln City Fire Department on SRP. He also training the Lincoln City Fire Department on Stop the Bleed.

Officer Fruge reported that the kids, at district #27, are getting excited about Spring. The most common incidents that Officer Fruge responded to were general counseling issues and fighting issues.
