



Lincoln Police Department Monthly Report

February 2022

Report Summary

The City of Lincoln Police Department Safe Passages Program has been transferred over to Unity Point Health. Unity Point Health is a new non-profit organization dedicated to meeting the growing behavioral healthcare needs of the community. They are proud to offer the most comprehensive addiction and mental health services in the region. The Lincoln Unity Point Health officer is located at 125 N. Sangamon Street, Lincoln, IL 62656. Their office phone number is 217-732-6865 and the Unity Point Access Center's phone number is 888-311-0321 and is available 24/7.

Lincoln Police responded to 937 incidents for the month and 94 case reports were written for the month. Officers responded to 24 vehicle crashes. Patrol officers wrote 55 traffic citations and 32 warnings for the month along with 1 City Ordinance Citation and 2 City Cannabis Ordinance Citations.

Of the 50 arrests for the month, officers arrested several for warrants, driving with suspended/revoked drivers license, domestic battery, and retail theft. Detectives continued investigations on 24 cases including participating in CIEG task force operations.

During the weeks of February 14th through February 25th, 2022, the Lincoln Police Department hosted its 2nd Annual D.A.R.E. Officer Training Program. The Department supports this program and its efforts to assist youths with sound judgement and decision making, including but not limited to resisting drug and alcohol abuse.

The goals of well-founded SRO programs include providing safe learning environments in our community's schools, providing valuable resources to school staff members, fostering positive relationships with youth, developing strategies to resolve problems affecting youth and protecting all students, so that they can reach their fullest potentials.

There were 24 crashes the Lincoln Police Department responded to for the month of February.

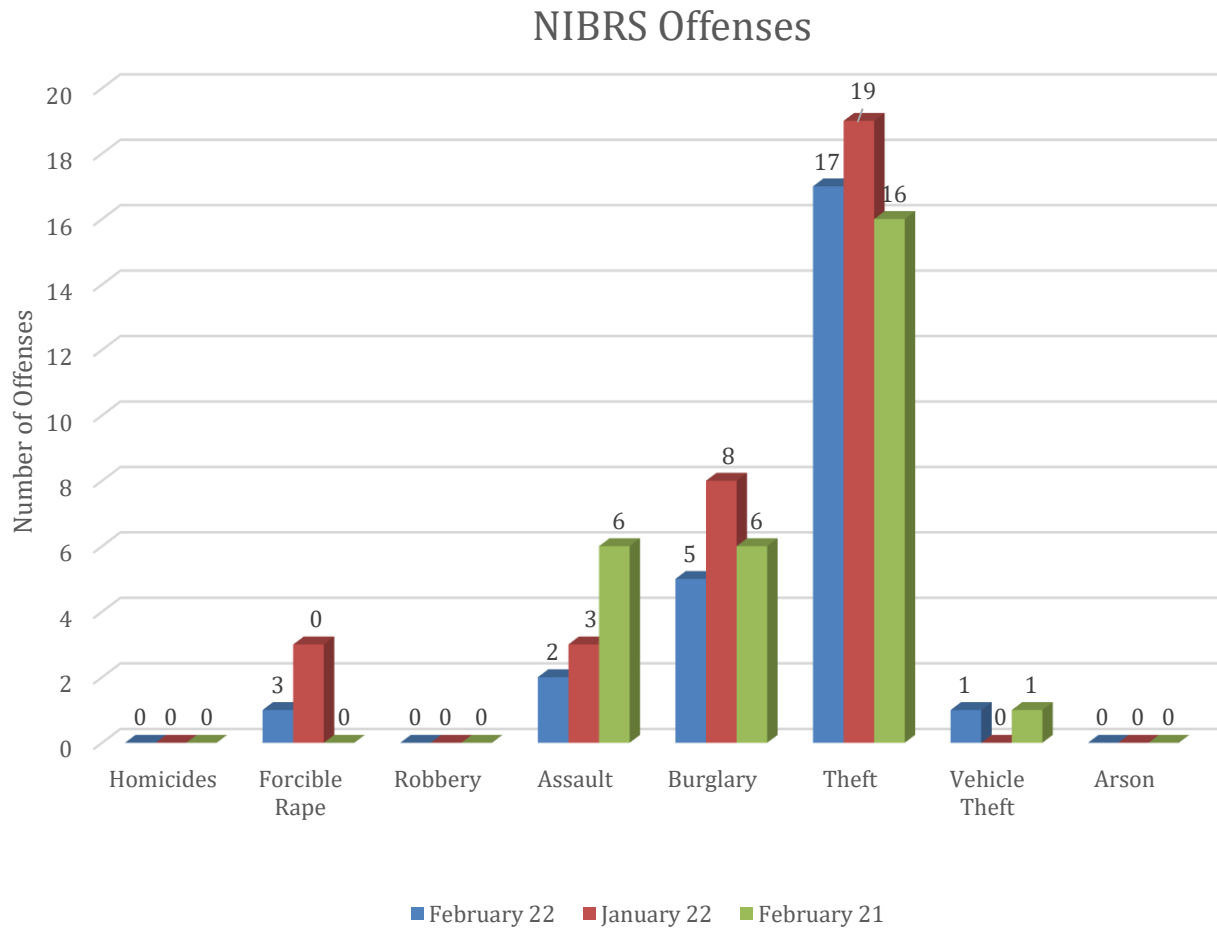

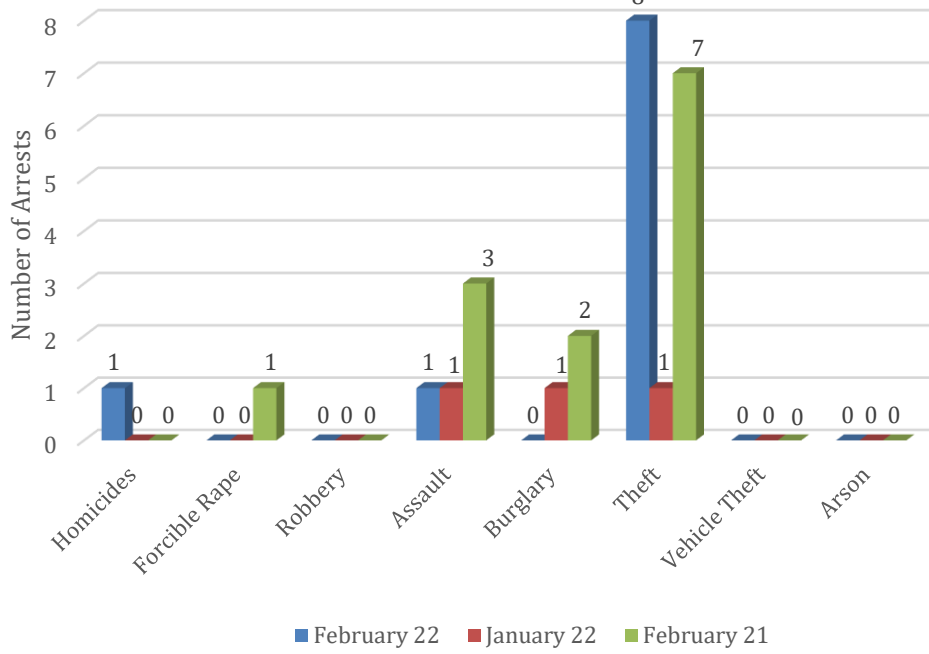
National Incident Based Reporting System (NIBRS)

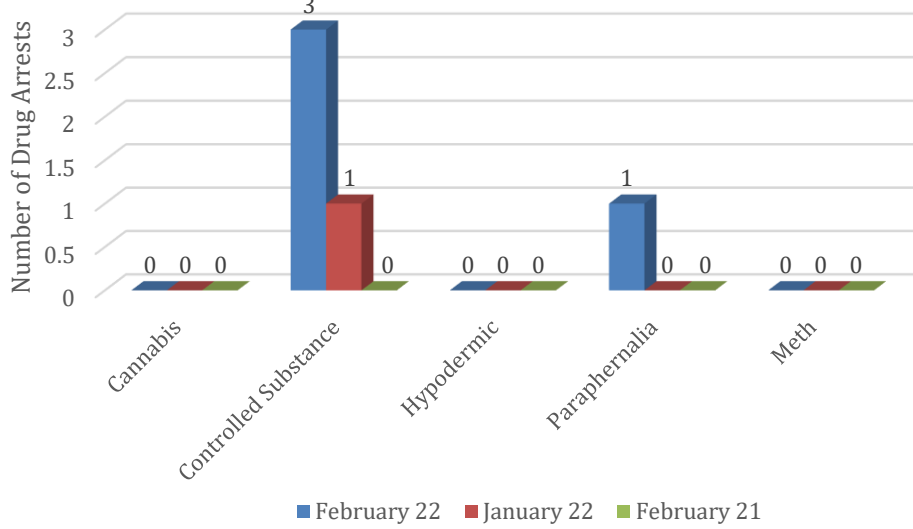
NIBRS Report for February 2022

Drug Crime Arrests



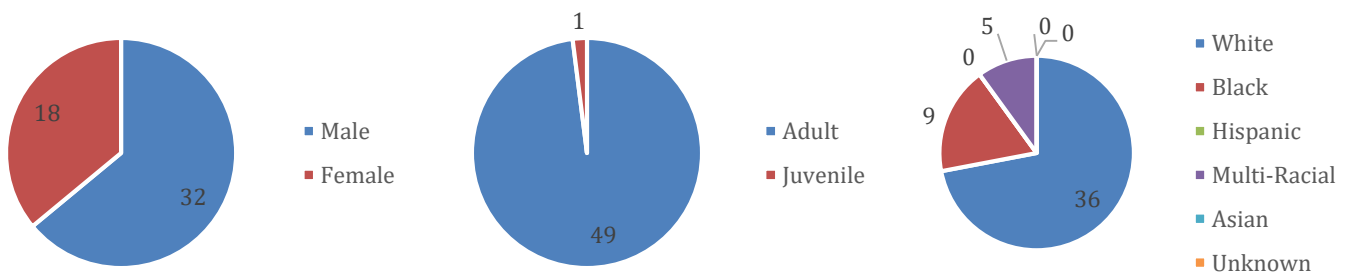

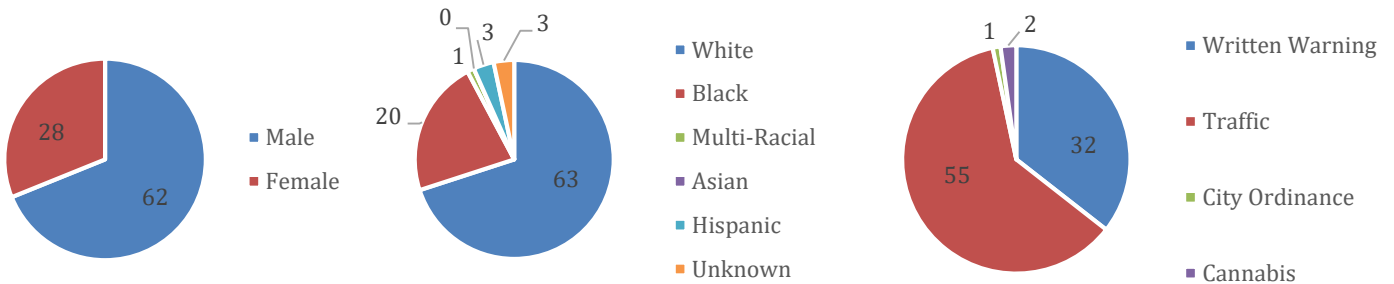

DIVISION REPORTS

Criminal Investigations

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on 24 active criminal investigations in the month of February. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available for release.

- (10) Investigations involved sexual offenses.
- (1) Death Investigation
- (3) Investigations involved crimes against persons.
- (9) Investigations were property related.
- (1) Investigations were narcotics related.
- With the resignation of a Detective, only one officer of the Criminal Investigations Division continued to participate in a multi-jurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.

DARE/Community Policing

During the weeks of February 14th through February 25th, 2022, the Lincoln Police Department hosted its 2nd Annual DARE Officer Training Program. The Department supports this program and its efforts to assist youths with sound judgement and decision making, including but not limited to resisting drug and alcohol abuse. DARE has curriculums designed for children as young as kindergarten, going all the way through to high school years. DARE is currently being taught to children in kindergarten thru 4th grade, in our community.

Officer Christy Fruge has the DARE annual Fundraising drive in gear. The money raised supports the DARE program by buying books and supplies for the DARE classes in our community schools.

Lincoln K9

Officer Sullivan and K9 Ace were dispatched for only one narcotics sniff for the month of February. K9 Ace did not indicate on that sniff.

School Resource for LCHS and District #27

The goals of well-founded SRO programs include providing safe learning environments in our community's schools, providing valuable resources to school staff members, fostering positive relationships with youth, developing strategies to resolve problems affecting youth and protecting all students, so that they can reach their fullest potentials. The three main roles of school resource officers are: educator (i.e. guest lecturer), informal counselor/mentor, and law enforcement officer.

Officer Butterfield spent a few weeks working cases in the Criminal Investigation Division of the Police Department and attended School Resource Officer Training. Officer Rohrer was able to spend some time, at LCHS, putting his training as a Student Resource Officer, into a working experience. They responded to incidents at LCHS about harassment/bully issues, social/emotional issues, mental health issues and other incidents that required parental contact.

Officer Fruge has responded to incidents at LJHS about social/emotional issues and general counseling issues that required parental contact, harassment/bullying issues and truancy.
